- An 8" sanitary sewer main would be superior to a 6" trunk. And the conversation of the correct placement alignment of the main trunk across the road.

Contacted DCED about no receiving the full amount requested and can the Authority contribute the remainder or should the project be lessened? No reply from DCED
- ➤ Submission of the PA Small Water and Sewer Grant- quote was \$49,500.00 to upgrade the control panel.
