

City of New Munich
City Council Minutes

June 3rd, 2019

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Ron Doll, Pat Nathe and Elmer Boecker were present.

On a motion by Ron Doll, seconded by Pat Nathe and carried the minutes from May 2019 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of 5 medical calls. Al mentioned he will install the weather station that was purchase last year on the edge of the city hall parking lot. Al presented two bills that needed to be paid Ramler Trucking for \$27.27 and postage for Al for \$11.00.

A motion was made by Ron Doll, seconded by Pat Nathe and carried the Resolution 6-19-B for a gambling permit for the Fire Department raffle.

Tom Valerius, Water/Waste Water Operator noted R-Way Pumping cleaned out the lift stations and Mike Nielson will be doing a complete overall cleaning on the lift stations this week. Tom noted he working on a permit for the ponds that is due July 1st, he needs a check for \$1,240.00.

Jaycee member, Sandy Zierden was present to get approval on a one day gambling resolution. On a motion by Shawn Duevel, seconded by Elmer Boecker and carried Resolution 6-19-A was approved. Sandy also asked if the Council could have permission to hide the medallions on city property for Munichfest, on a motion by Shawn Duevel, seconded by Elmer Boecker and carried the approval.

On a motion by Elmer Boecker, seconded by Ron Doll and carried the following building permit was approved for Jim Sand.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the contract from Belgrade Co-op for propane at \$1.24 was approved.

On a motion by Shawn Duevel, seconded by Elmer Boecker and carried the Xcel Energy Franchise Agreement was approved.

Summering watering will be in effect in June. Wastewater charges for seasonal watering will be a volume based on the average monthly water usage of January, February and March and this usage will be utilized to determine the charges for June, July and August wastewater charges. Water will be billed out as normal. Swimming pools water fills will be billed at as normal.

On a motion by Pat Nathe, seconded by Elmer Boecker and carried the approval of the quote provided by Oak Electric Services to upgrade service to 200amp and install new panel in pump house due to the main breaker failures, quote was approved for \$5,500.00.

Regarding the lots are for sale in town, the council suggested to list them with a realtor, on a motion by Ron Doll, seconded by Shawn Duevel and carried the approval to list the lots with a realtor.

On a motion by Ron Doll, seconded by Elmer Boecker and carried the Local Government Aid will go into the general fund.

Financial Statements were approved on a motion by Elmer Boecker, seconded by Pat Nathe.
