Dansville ArtWorks is seeking area photographers for our upcoming juried exhibition at 153 Main Street, Dansville, NY. The theme is open and selected artists will be exhibited during February and March 2018. All photo processes are welcome.

For this exhibit, Dansville ArtWorks is pleased to announce our Juror, Christine Berry. Ms. Berry opened Berry Campbell Gallery with Martha Campbell in 2013. The 2,000 square-foot gallery is located at 530 West 24<sup>th</sup> Street on the ground floor in the heart of Chelsea in New York City. Berry Campbell features Post-war modern and contemporary art with a focus on established and mid-career contemporary artists.

Christine Berry recently participated on a panel for the American Abstract Artists' Group, was quoted in *Bloomberg News* on the art market, was a guest lecturer for the Sotheby's Art Institute, Baruch College, the Arts Students League and co-curated the Center for Maine Contemporary Art's 2016 Biennial with John Yau.

Christine Berry is originally from Geneseo, New York and earned her Bachelor of Arts in Art History from Baylor University, Waco, Texas and her Master of Arts in Art History and Museum Studies from the University of North Texas, Denton, Texas. She began her career at the Modern Art Museum of Fort Worth, working under Chief Curator, Michael Auping and continued on to the Whitney Museum of American Art. Over sixteen years ago, she shifted from the non-profit sector to the commercial art world. Christine continues to place art in the world's foremost public and private collections.

#### **Awards**

Three photographers will be designated best of show by the juror and receive cash prizes in the amounts of \$100, \$50 and \$25. An additional People's Choice Award, a \$25 gift certificate, will be given based on visitor votes during the opening reception.

### **Guidelines for Submitting Items**

- Submit up to 3 items. Decisions about acceptance and best of show awards will be made by the juror, and all decisions are final.
- Accepted artwork must be delivered in person on delivery day and picked up on pick-up day. If you have a hardship, please contact <a href="mailto:dansvilleartworks@gmail.com">dansvilleartworks@gmail.com</a>.
- Accepted artwork must be ready to hang with wire hanging on back and plexiglass is preferred to glass in the frame, if possible.
- All items must be original and the work of the artist. Only photography will be considered; no additional elements/mixed media for this exhibit.
- Artists must be 18 years of age or older.
- All items must be family friendly. If you are not sure, then it probably is not.
- All juror decisions are final.
- Accepted artwork should be for sale. Dansville ArtWorks will receive a 25% commission for your sale. All sales transactions during the exhibit will be handled by Dansville ArtWorks. Artist's portion of sales will be issued within 10 business days following exhibit close. If Dansville ArtWorks facilitates a purchase on the artist's behalf that is OUTSIDE of the gallery submission process outlined for this exhibit, Dansville ArtWorks will require a brokerage fee per piece which will be 35% of the purchase price. Again, this is only for sales outside of the accepted items (including prints) and only sales that require Dansville ArtWorks' facilitation.
- If accepted, items must be delivered during designated drop off times. Any artist leaving items
  without receipt from a Dansville ArtWorks representative assumes <u>all</u> risk and responsibility for
  items.

### **Entry Fee**

- A <u>non-refundable</u> entry fee of \$10 per piece is due along with the Submission Form. Make checks
  or money orders payable to: Dansville ArtWorks. Debit/credit cards also are accepted. The
  submission process is not complete until payment is received.
- Checks returned for insufficient funds or closed accounts will be subject to an additional collection fee of \$35.

- Submissions due no later than January 6, 2018.
- Please email up to three (3) photos in .jpg format for juror use and possible use in promotional materials and social media; each image labeled with title and your name to: DansvilleArtWorks@gmail.com. Be sure to sign the photo release section of the submission form.
