# The Legislators

#### **General Assembly**

The Ohio General Assembly sets the rules and regulations for the operation for each of Ohio's 5 retirement systems: Public Employees, State Teachers, School Employees, Police & Fire, and Highway Patrol.

#### Ohio Retirement Study Council

The Ohio Retirement Study Council, a council within the General Assembly, monitors each of the retirement systems. They, in-turn, make recommendations to the various legislative committees about pension related matters.

### The Boards

#### **Ohio Retirement System Boards**

Each of the 5 retirement systems has a board of trustees.

These boards consist of:

- 4 or 5 current worker and 2 retiree elected members
- 3 financial-expert members, 1 each appointed by the Governor, the Treasurer, and the General Assembly
- 3 of the systems have 1 statutory member.

These men and women have the fiduciary responsibility of overseeing their pension fund investments and healthcare benefits under the rules and regulations set down in the Ohio Revised Code.



## An Association for all Impacted Parties

#### Protect Ohio Pensions, Inc.

Our membership is open to all retired and current worker members from each of Ohio's 5 public pension systems.

We are joined together for the purpose of building the largest and strongest association possible, for addressing issues that are potentially harmful to the health and well-being of Ohio's defined benefit pension funds, and to the health care benefits they provide.

We have established the acronym (POP5) to identify not only <u>Protect Ohio Pensions</u>, Inc., but also the <u>5</u> Ohio pension systems.



### An Association for All (continued\_1)

Protect Ohio Pensions, Inc. monitors every special interest, or politically motivated, piece of legislation that is introduced, or about to be introduced.

We then measure its potential impact on the continued existence of Ohio's defined benefit pension funds, or upon any pension-system board member's ability to carry out his, or her, investment responsibility to act solely in the best interest of participants and beneficiaries\* as expressed in the Ohio Revised Code.

### An Association for All (continued\_2)

When a concern arises, we will discuss the situation with the appropriate leaders of Ohio's pension systems, the Ohio Retirement Study Council and the Ohio General Assembly.

From the results of those discussions, we will develop and propose an appropriate promotional, or legislative, plan of action for our membership.

Drawing from the information they will receive from Protect Ohio Pensions, members will then have the facts, and consequently the ability, to help protect and preserve Ohio's defined benefit pension funds and the benefits they provide to us and the Ohio economy alike.

### **Accurate and Timely**

Pension system retirees and members need an accurate and timely source for information about special interest, or politically-motivated legislation, that would have a negative impact on their retirement paychecks and health care benefits.

The retirement boards we elect, and the staffs that run our pension systems, have to depend on us to protect them from outside influences that can damage or eliminate our Ohio defined benefit pension plans.

We need to be willing to learn and act so that the pension systems can continue to provide us with health care and paychecks.
