

**AMELIA VILLAGE, OHIO
ORDINANCE: O-2015-40**

**AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, OHIO
ADOPTING AMENDED APPROPRIATIONS OF VILLAGE FUNDS FOR THE
FISCAL YEAR ENDING DECEMBER 31, 2015 FOR AMELIA VILLAGE**

WHEREAS, the Village is required by statute to prepare and adopt annual permanent appropriations of village revenues for current expenses and other expenditures for the fiscal year ending December 31, 2015.

WHEREAS, on March 10, 2015, the Village Council adopted Ordinance Number 0-2015-17 authorizing the permanent appropriations for current expenses and other expenditures during fiscal year 2015; and

WHEREAS, amended appropriations are necessary at this time, to provide for the current expenses and other expenditures of Amelia Village during said fiscal year.

NOW THEREFORE BE IT ORDAINED by the Amelia Village Council as follows:

SECTION I. It is necessary to provide for additional expenditures of Amelia Village during the year ending December 31, 2015, the following amounts be and they are hereby set aside and appropriated as follows:

SECTION II. That the following sums be and are hereby set aside and appropriated from the several Funds, to wit:

SECTION III. Village Council finds these supplemental appropriations are necessary to provide sufficient funds for the several obligations of the Village.

SECTION IV. The Village Fiscal Officer is hereby directed to make the supplemental appropriations as outlined in this Ordinance.

SECTION V. That the Village Fiscal Officer is authorized by Council to make intrafund appropriation transfers as needed and that the Village Fiscal Officer shall notify Council in writing of any such intrafund appropriation transfers made at the next scheduled meeting of Village Council.

SECTION VI. That the Amelia Village Council finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and, that all deliberations of the council and of its committees, if any, which resulted in the formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION VII. That this Ordinance shall take effect and be in force at the earliest time allowed by law.

MR. Campbell moved to suspend the rules requiring three readings on three separate dates.
