Regular meeting-----April 5, 1982

The minutes of March 15, 1982 meeting was read by Donna Jo Koskinen. A Motion by George White and seconded by D.L. Taylor to approve the minutes as read. MOTION CARRIED. MINUTES

K.E. McDougald reported to the Board that all the leaks at Ken's Lake have been repaired. LEAKS AT KEN'S LAKE

Nate Rhodes of Rhodes Bros, Fillmore, Utah, came down to Moab and met with David Bretzke. David took him out to all the wells. Nate Rhodes agreed that George White Well #4 needed a lot of work. K.E. McDougald suggested that we get this well in working order as soon as possible. George White stated that George White Well #4 was in good shape, but a backup well was needed in case of an emergency. K.E. McDougald talked to Mayor Tom Stocks and it was agreed upon that in an emergency, Spanish Valley could use the Corbin Well. TOM STOCKS
