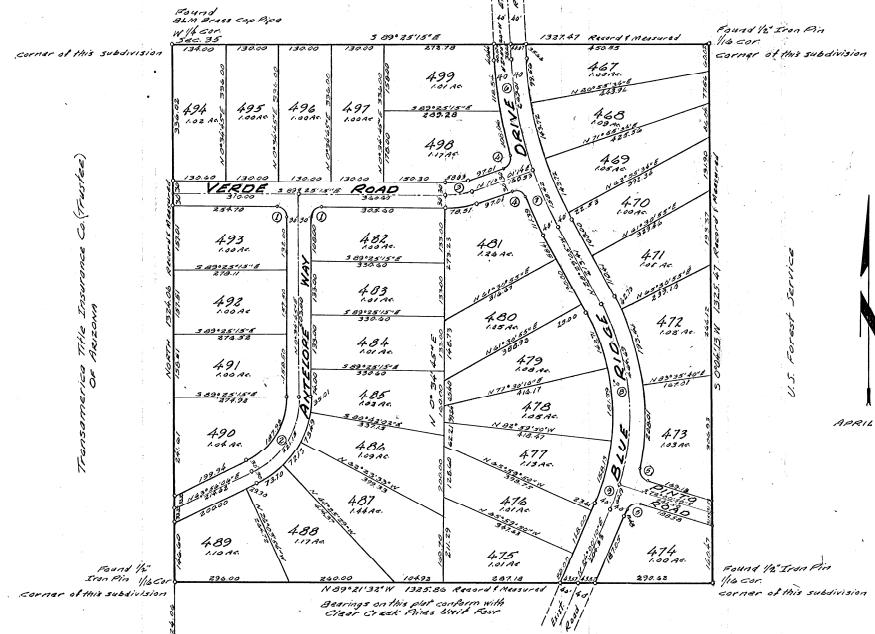


SHEET ONE OF ONE TRACT NO. 1040

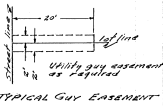
