Proceedings were aired live on Facebook.

Mayor Gary Davenport called the meeting to order: 6:02 p.m.

The Invocation was then given by Daren Davis

Mayor Davenport opened the meeting by thanking the public for the opportunity to serve for all these years. He then introduced Representative Reed Ingram as the chosen person to administer the Oaths of office for the New Mayor and Council.

Mayor Sanders, Jackie Stearns (Place 1), Daren Davis (Place 2), Wanda Estes (Place 3), Colby Bellew (Place 4) and Tammie Willis (Place 5) were then sworn in officially.

Mayor Sanders took over asked if anyone would entertain a motion to suspend the reading in full of the below mentioned Resolutions providing the key points are mentioned.

A motion to suspend the reading in full of the following Resolutions was made by Councilor Bellew and seconded by Councilor Estes. A roll call vote was taken (5 yea). Motion passes.

Mayor Sanders introduced Resolution 2025-11-002 to appoint Justin Edwards as the town attorney for the 4-year term.


A motion to approve Resolution 2025-11-002 to appoint Justin Edwards as the town attorney for a 4-year term was made by Councilor Bellew and seconded by Pro-Tem Estes. A roll call vote was taken (5 yea). Motion passes.

Mayor Sanders introduced Resolution 2025-11-003 to appoint Joseph Fuller as the Municipal Judge for the 4-year term.

Representative Reed Ingram administered the Oaths of office to the following appointed individuals; Robert Head, Shannon Duck, Joshua Dorminey, Kira Hornsby, Joseph Fuller, Guy Sanders and Wanda Estes.

Local pastors then did a blessing in prayer over the newly elected officials.

A motion to adjourn at 6:29 p.m. was made by Councilor Davis and seconded by Councilor Bellew. (5 yea). Motion passes.
