* The Improvement Center will open at 10 AM for drop off and set up. Arrive for the party at 4PM dinner by 5PM.

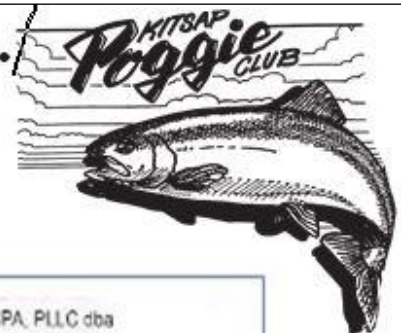



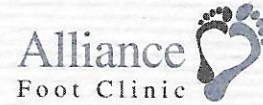
