SOLICITOR'S REPORT Mr. Racunas, Solicitor, reporting

Mr. Racunas called for a motion to advertise with the intent to adopt Ordinance 2020-03 amending the Non-Uniform Pension Plan administered by the Pennsylvania Municipal Retirement System. The motion was made by Mr.

Matlos and seconded by Mrs. McClelland and passed unanimously. Motion carried.

ENGINEER'S REPORT Adam Prince, Engineer, reporting

Mr. Prince asked if Council wants Glenn Engineering to design specifications for the B Street sewer project. There will be a \$22,000 match from the Borough. The grant money is awarded for that project specifically. Council is all in favor of moving forward with the project. Motion to accept the grant from Steel Rivers COG for the B Street storm sewer project. We received a grant of \$41,470 for the construction cost

Mr. Zrenchak called for a motion to accept the grant funding. The motion was made by Mr. Matlos and seconded by Mrs. McClelland and passed unanimously. Motion carried.

Mr. Prince mentioned the application for the DCED grant for the blight remediation project. He said that the application is only \$100 to potentially get \$300,000. Motion to apply for the DCED blight remediation grant. The motion was made by Mrs. McClelland and seconded by Mr. Matlos and passed unanimously. Motion carried.

NEW BUSINESS

Motion to accept street sweeping agreement effective May 13, 2020. The motion was made by Mr. Matlos and seconded by Mr. Sloss and passed unanimously. Motion carried.

Motion to accept salt agreement with Cargil effective May 13, 2020. The motion was made by Mr. Matlos and seconded by Mrs. McClelland and passed unanimously. Motion carried.

Mr. Wall said that Foster and Sons does not carry the hand soap that we use now and the new soap has a different dispenser which they will give us at no charge.

Motion to accept the typed minutes from Wednesday, May 13, 2020. The motion was made by Mr. Matlos and seconded by Mr. Gretz and passed unanimously. Motion carried.

Mr. Zrenchak mentioned the scuttlebutt about the Memorial celebration. It was kept at the requirements of 10 people or less. It was appropriate to honor the veterans and was done following guidelines.
