

# WHAT IS SM-102?

## WHY IS IT IN THE COVID-19 INJECTIONS

Many Researchers have discovered the source documents of one such producer in the Caribbean that makes the solution, SM-102. [Safety Data Sheet acc. to OSHA HCS](#). The document was published by the Cayman Chemical Company of Ann Arbor, Michigan. The following documents were obtained directly off their public website. Here is the confirmation that indeed, the composition of SM-102 is so poisonous and toxic, it should be used in Humans nor in Animals. The question then should be logically asked. Then why is it being used in the COVID-19 Injections? What possible benefit will have? None.

On the contrary, it is not about fighting-off the 'virus' but to inject every human being possible with the Nano-Particulates. Why? *-Causes damage to the Central Nervous System, the Kidneys, the Liver and the Respiratory System through prolonged or repeated exposure.*

*-Very toxic to Aquatic Life with long lasting effects.*

The proponents of the Moderna COVID-19 Injections as well as of the others might very well argue that the dosage in each Injection of SM-10 is 'minuscule' and not an issue nor danger to the Person. - **Ingredients:** messenger ribonucleic acid (mRNA) lipids (((4-hydroxybutyl)azanediyl)bis(hexane-6,1-diyl) bis(2-hexyldecanoate), 2 [(polyethylene glycol)-2000]-N,N-ditetradecylacetamide, 1,2-distearoyl-sn-glycero-3-phosphocholine, and cholesterol), potassium chloride, monobasic potassium phosphate, sodium chloride, dibasic sodium phosphate dihydrate, and sucrose
- **Explanation of ingredients:**
  - **Lipids:** Nanolipids, or tiny fat molecules, protect the mRNA and provide a "greasy" exterior that helps the mRNA slide inside cells. Nanolipid components in the Pfizer-BioNTech vaccine include: (((4-hydroxybutyl)azanediyl)bis(hexane-6,1-diyl)bis(2-hexyldecanoate), 2 [(polyethylene glycol)-2000]-N,N-ditetradecylacetamide, 1,2-distearoyl-sn-glycero-3-phosphocholine, and cholesterol

- **Ingredients:** messenger ribonucleic acid (mRNA), lipids (SM-102), polyethylene glycol [PEG] 2000 dimyristoyl glycerol [DMG], cholesterol, and 1,2-distearoyl-sn-glycero-3-phosphocholine [DSPC], tromethamine, tromethamine hydrochloride, acetic acid, sodium acetate, and sucrose
- **Explanation of ingredients:**
  - mRNA: Like the Pfizer BioNTech vaccine, Moderna's also uses mRNA technology to build antibodies against COVID-19.
  - Lipids: Nanolipids help deliver the mRNA to the vaccine recipient's cells. Nanolipid components of the Moderna vaccine include: (SM-102, 1,2-dimyristoyl-rac-glycero3-methoxypolyethylene glycol-2000 [PEG2000-DMG], cholesterol, and 1,2-distearoyl-snglycero-3-phosphocholine [DSPC])
