COUNCIL MEETING

SEPTEMBER 3, 2020

Meeting was called to order by Mayor Patrick Edwards at 7:05 p.m. Roll call: Cindy Humke, Cathi Fouts, Chris Norman, and Chris Wood present. Absent: John Bartello.

Guests: Jordan Hostetler – Jordan said that Manatt's was still on target for previously determined end dates for Pioneer Drive project and has submitted an application for partial payment. Roll call vote to approve this partial payment- 4 ayes - 0 nayes. Check was signed at Council meeting and will be mailed out the next day.

New Business:

- a. During the DOT storm debris pick up there was damage done to curbs on Pioneer Drive, Emerson Hough, and Memory Lane. Manatt's has provided us with a quote that we will submit to FEMA to request reimbursement for the repair.
- b. FEMA application has been submitted and awaiting approval. The City of Lambs grove will be asking for reimbursement for the following damages:
 - i. manhole sleeve on Tonca Trail Jasper Construction to be doing a quote for us
 - ii. Tree Removal form OGG park
 - iii. Landfill tipping for DOT debris removal
 - iv. Curb repairs on Pioneer Drive, Emerson Hough, and Memory Lane to be done by Manatt's.
 - v. Repair of Lambs Grove sign uplighting will be done by Drewis Electric. They are to be providing us with a quote for those costs.
- c & d. 2nd DOT pick update is awaiting approval and confirmation by DOT. Residents will be made aware of this date once Mayor Edwards hears from them with a date.
- e. Fouts moved to approve Resolution 2020-12 authorizing the 2020-2021 Street Financing Report. Wood seconded this motion. Roll call vote was 3 ayes and 1 absent. Resolution 2020-12 shall be approved and added to the City records.

Consent Agenda:

Humke moved and was seconded by Norman to approve all the items on the consent agenda including the minutes from the August 6, 2020 meeting, list of bills, and reconciliation report for August. Motion carried 4-0.

Streets: Andreas acquired the paint and supplies needed for Norman to start painting the crosswalks on the streets. Norman will start this once work on Pioneer Road has been completed.

Sewers: Bartello was absent and Mayor Edwards informed us that Bartello would be absent for the foreseeable future. Norman is to take over all Sewer Steward duties until Bartello's return.

Parks: Humke reported that the parks she has removed all storm debris from our parks.

Tree Steward: all matters of tree damage and removal had already been covered by this time.

Storm Sewers: There is storm damage to the manhole sleeve at 110 Tonca Trail from a fallen tree. Awaiting a quote for this and it will be turned in to FEMA for reimbursement.

City Clerk: No report

Old Business: Jordan Hostetler said that the Pioneer Drive Project is on target with all dates set up for completion of this project, even with the week off they had to take due to storm damage.

Fouts moved and was seconded by Wood to adjourn the meeting at 8:00 p.m. Motion carried 4-0.
