October 15, 2018

The Town Council met October 15, 2018 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight asked for approval of the Council Minutes from October 1, 2018.

Mayor Hight asked Fire Chief Connor about the Drill field. Connor reported they have the ac unit to be installed and they are looking at have a work day in November to get everything cleaned up and do some painting.

Terry Jackson reported Richard Wood Park. He also reported that he insurance company totaled the 1988 Dump Truck and paid the Town \$4882.00 and also said the Town could keep the truck. Terry asked about putting it on Gov. Deals.
