WHEREAS, the Board of Commissioners of East Baton Rouge Parish Fire Protection District No.6 created the East Baton Rouge Fire District 6 Fire Prevention Bureau to conduct fire safety inspections within East Baton Rouge Parish.

WHEREAS, the East Baton Rouge Fire District 6 Fire Prevention Bureau was created in pursuit to Louisiana RS 40:1563.


