

# Town of Baldwin, Maine SELECTMEN MEETING MINUTES TUESDAY, JULY 31, 2018, 6:30 P.M.

1. Selectmen Meeting was called to order approximately at 6:31 PM by Jeffrey Sanborn.

#### 2. Review/ Approve meeting minutes

Jim Dolloff made a motion to accept and approve July 17, 2018 meeting minutes. Dwight Warren seconded the motion. Selectmen voted 3-0 to approve meeting minutes.

### Follow-up on Freemont Avenue speed problem

Selectmen reviewed issue on Freemont Avenue. The MaineDOT was contacted and a speed study was requested, but an estimate wait time of 6 months was given. The MaineDOT also explained that reducing the speed would not be efficient without enforcement. Selectmen recommended to contact the Sherriff's office and review the option of installing a blinking light at the intersection of Freemont Avenue and Route 113.
