Hello Neighbors and Friends in the Community of Nolan River Estates. Our Community Clean Up Days are very well received and participation is among the best of all our monthly activities. Coming up in early May is our annual dumpster program which will likely be located near the corner of St. Leger and Gold Cup in the usual place. ## **Food For Thought**

Despite what some folks may tell ya, you don't have to be a farmer to be outstanding in your field!

#### **Pipeline Progress**

If you are like me, you may have grown so accustomed to the pipeline crews, the heavy equipment, the trucks, and the orange caution signs--you may have overlooked that much of the disturbed earth is now being remediated to near its original condition (short of vegetation) I am personally amazed that this company is able to smooth some of these rocky areas back to manicured areas! They still have a way to go but the progress is noticeable on a weekly basis.

Each resident is encouraged to study their property wherein pipeline work or transit to and from pipeline work may have impacted their property condition. You should email any Board member if concerns arise regarding Troy Pipeline's agreement to properly remediate the right-of-way while completing this large project.

#### **Animal Care**

Resident Marcea Haubert has provided two superb articles regarding pet and animal care. Links to these two documents have been placed on the Resources Tab of the NRE Website. the first link is called Paw-scape and delineates several common types of plants that many of us have in our landscapes and/or gardens--but which are quite toxic to our pets once ingested. Who would have thought such common plants as Aloe Vera, Boston Ivy, Diffenbachia, and Poinsettia could be fatal to a pet? The second two page article is produced by the Humane Society and gives great detail on how to plan a care and defensive posture to protect both large farm stock as well as household pets in the event of severe weather and other types of natural disasters wherein we may not consider them in the moment of chaos during and following inclement or life threatening weather events or other natural disasters. Simply click on the links on the resource page on the NRE website and check out these two great pieces of information.

#### **Poison Ivy**

"Late at night, she'll come a creepin" as the old fifties song use to say but have no fear this pesky plant found all over our area has no limits on time of day to pour out her itchy grief on the folks who do not know how to identify it and more importantly--stay away from it. Other than providing severe itching, swelling, and great discomfort this critter can be life threatening if you or your neighbor has a big burning campaign in progress. It takes very little of this ivy casually wrapped around a felled tree, to create respiratory havoc when added to the burn pile. The oil from the ivy is easily atomized and carried far and wide for innocents to breath. Please pay attention--particularly when burning property not to inhale or let this smoke get in your eyes or worse, lungs. I have



personally danced with this treacherous lady on several occasions here on CR 1219 and spent weeks of torture trying to get rid of her.
