Supervisor May called the board meeting to order at 7:00 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York.

Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting.

Supervisor May introduced Ms. Cindy Goral, Tri Town Seniors. Ms. Goral thank the Board for their support and funds for the group. Ms. Goral discussed what the group has done this year, and handed in a report of all activity. They have 57 members currently.

Supervisor May requested an amendment to the October 13, 2022 minutes. Zoning Officer Report: Information regarding the two solar requests from Town residents have been sent to Mr. David DiMatteo for his review and discussion.

Highway Superintendents Report:

CHIPS is suppose to be in on the 15th, Should be in two different payments. Working on computers, mine will no longer be supported with windows, it will not longer update. Hired Dean Smith to work for the remainder of winter and Karissa Roggow for office work during break. Gary Whitmore is done and Wyatt will not be able to work this winter. Checked on the trucks, 10 wheeler and the pickup – Capalino does not have the pricing for 2023, the Bid windows are sometimes only open for a very small time frame. Check Conroy's, prices out a truck identical to ours, \$53,495.16 without a plow. [An LT model, will be decent resale.] We have completed this twice and the dealer backed out.

Supervisor May, we can take surplus from __, The Board preauthorizes to purchase 2023 truck with fisher plow from Cappalino at \$59,697.00, d/t the truck market. A letter of intent will be sent. On a motion by Mr. Flint, seconded by Mr. Herman to preauthorize the purchase, to transfer \$59,697.00 from fund

To the general fund, \$121.00, Dogs were \$86.00, Late fee - \$35.00. We disbursed \$155.00 to Wyoming County, \$38.00 to Ag and Markets for dogs. We have been working with Spectrum regarding our phone system.
