Supplemental Nutrition Assistance Program (SNAP)


Provides low-income households electronic benefits redeemable for SNAP-eligible foods at SNAP retailers. Benefit amounts vary by household size and benefit calculation rules.

Supplemental Nutrition Assistance Program (SNAP)

Why Does It Matter?

"The Supplemental Nutrition Assistance Program (SNAP, formerly "food stamps") is the largest nutrition assistance program administered by the U.S. Department of Agriculture (USDA). SNAP serves as the first line of the nation's public policy defense against hunger and undernutrition as well as an effective anti-poverty initiative. SNAP has a critical role, not just in reducing food insecurity, but in improving the health of the nation, especially among the most vulnerable Americans."

Supplemental Nutrition Assistance Program (SNAP) Points of Contention

"Some advocates for SNAP reform are taking a "carrot" approach, calling for an increase in programs that double the purchasing power of recipients to buy fresh produce in farmers markets or stores. Others argue for a "stick" approach such as restricting the use of benefits for sugar-sweetened beverages. The anti-hunger community has largely rebuffed any attempts to limit the free choice of recipients as an assault on personal dignity."

Supplemental Nutrition Assistance Program (SNAP)

Points of Contention

"Improving diets for SNAP recipients, however, could improve not only their health and well-being, but also their economic status. While it remains to be seen whether restrictions could improve diet and health, the potential to boost productivity and reduce healthcare costs by investing in chronic disease prevention war ents serious consideration."

2018 Farm Bill (P.L. 115-334) <u>Title IV, Nutrition, Subtitle C, Sec. 4205</u>

Gus Schumacher Nutrition Incentive Program

Provides competitive grants for projects that increase lowincome consumers' purchase of fruits and vegetables by providing incentives at SNAP points of purchase or (added by 2018 farm bill) providing produce prescriptions to SNAP/Medicaid participants.

Gus Schumacher Nutrition Incentive Program (formerly FINI Program)

- FINI enhances SNAP by increasing buying power for fruits and vegetables.
- Included in the 2018 Farm Bill as an entitlement program, an improvement over the 2014 Farm Bill.
- One study of stakeholders and FINI grantees emphasized overwhelming positive impacts of the FINI grants including:
 - 1) Farmers experienced an increase in sales of produce and expansion of their customer base;
 - 2) Grocery store owners saw an increase in sales of produce and were able to expand their offering of locally sourced produce; and
 - 3) Consumers utilizing FINI incentives reported improvements in their diet (i.e. increased fruit and vegetable intake), food security and better health.

2018 Farm Bill (P.L. 115-334)

<u>Title IV, Nutrition, Subtitle C, Sec. 4204</u> Healthy Food Financing Initiative (HFFI)

Reauthorizes the HFFI and expands edible projects beyond retail to include healthy food enterprises such as food hubs, mobile markets, direct to consumer markets, or food business incubators.

Expands access to healthy food for low-income communities and communities of color.

The new bill expands HFFI investments beyond retail to food enterprises, building on the existing program that seeks to bring healthy food and jobs to communities nationwide.

Healthy Food Financing Initiative (HFFI) (cont'd)

In addition to the existing program at the U.S. Department of Agriculture (USDA), HFFI has been supported at the U.S. Department of the Treasury and U.S. Department of Health and Human Services (DHHS).

The HFFI has supported nearly 1,000 grocery and other healthy food retail projects in more than 35 states across the country, revitalizing economies, creating jobs, and improving health.

<u>El Paso, Texas</u> <u>Healthy Food Financing Initiative (HFFI)</u>

- Public-private partnership aiming to increase access to healthy food for residents by encouraging development and expansion of healthy food retail and related infrastructure.
- First ever county-level HFFI program in the United States.

<u>El Paso, Texas</u> <u>Healthy Food Financing Initiative (HFFI)</u>

• Through funding from Paso del Norte Healthy Foundation's Healthy Eating Active Living Initiative, the Institute of Healthy Living (IHL) convened with multiple partners to address healthy food access and provide additional programs, including nutrition education, cooking classes, health screenings, and increased access to federal funding through SNAP.


FOOD ACCESS IMPACT PYRAMID

Title IV, Nutrition, Subtitle A, Sec. 4017 Community Food Projects

Provides grants to nonprofit organizations for programs that improve access to locally produced food for lowincome households.

2018 Farm Bill (P.L. 115-334)

Title IV, Nutrition, Subtitle A, Sec. 4017

Senior Farmers' Market Nutrition Program (SFMNP)

Provides vouchers/coupons to low-income seniors to purchase fresh produce at farmers' markets and other direct-to-consumer venues.

Implications & Take Home Message:

- Registered dietitian nutritionists are well positioned to be leaders in ensuring that nutrition programs within the Farm Bill (e.g., SNAP, Gus Schumacher Nutrition Incentive Program, HFFI), are well funded, designed, implemented, and evaluated.
- The Farm Bill is a "Food Bill."
- One of the biggest challenges is offering a basic nutritional safety net that meets Dietary Guidelines for Americans, jointly produced by the USDA and US Department of Health and Human Services (DHHS), and at the same time involves the nation's farmers in that food system.
