#### **DIVISION 4. – LITTERING [4]**

##### **Sec. 25-141. - Owners, operators, lessees and employees of drive-in establishments to prevent accumulation of rubbish on premises or in the street.**

The owners, operators, lessees and employees of all businesses engaged in on-premises or off-premises service or who make deliveries of goods to customers in parking areas adjacent to the streets of the city, shall see to it that the wrappings, containers and other papers which enclose or accompany such goods are not thrown or deposited or allowed to blow upon the premises of such business, the streets of the city or any other premises. If any wrapping, container, napkin, straw or other accompanying paper or trash shall accidentally fall or blow upon the streets of the city, the premises of the business or any other premises, the owners, operators, lessees, and employees of such establishments engaged in such service shall be jointly or severally responsible with the customers thereof for the immediate removal of the wrapping, container, napkin, straw or accompanying paper or trash from the street.

##### **Sec. 25-142. - Dumping garbage in other than sanitary landfill.**

It shall be unlawful for any person to dump or cause to be dumped any garbage upon any property other than a sanitary landfill as defined in section 25-31.

##### **Sec. 25-143. - Depositing garbage, rubbish, or other refuse on streets, premises of another.**

It shall be unlawful for any person to sweep, throw or otherwise deposit or cause to be swept, thrown or otherwise deposited any garbage, rubbish or other refuse into or on any public street, alley, sidewalk, park or the property of another person or property which is in the possession of another person within the city, or to permit any garbage, rubbish or other refuse to accumulate in such manner that it may be carried and deposited into or on any of such places by action of the rain, wind or snow.

**Sec. 25-144. - Depositing garbage, rubbish and other refuse in streams, sewers, drains or basins.**

It shall be unlawful for any person to sweep, throw or deposit or cause to be swept, thrown or deposited into or on any canal, stream, public water drain, sewer or receiving basin, within the city, any garbage, rubbish or other refuse or to permit the same to accumulate in such manner that it may be carried and deposited into or on any of the places enumerated in this section by action of rain, wind or snow.

**Sec. 25-145. - Imposition of fines for violations.**

Any person found to have violated this section shall be subject to the fines and penalties provided in section 1-6 of this Code. The fine shall be determined based on the following:

- (1) First violation. For first violation, upon conviction, the fine shall be a minimum of \$250.00 or ten hours of community service.
- (2) Second violation and all subsequent violations. For second violation and any subsequent violation within a 12-month period, upon conviction, the fine shall be a minimum of \$500.00 or 20 hours of community service.
