IF YOU ARE SICK PLEASE STAY HOME – DON'T RISK INFECTING OTHERS

1) Driver Check-in

a. Temperatures will be taken of all participants at Check-in. The CDC indicates 100.4 degrees is the magic number. Should a participant have a fever, they will not be allowed to participate in the event.

2) Masks must be worn (over the nose and mouth) as follows:

a. At all times while in the Hot Pit Area or while on the drivers stand.

b. If you are having conversation with one or more persons and you're within 6' you must wear your mask. If you are having conversation within your pit area with other boaters, please wear your mask.

c. (Please provide your own mask)

D. Failure to adhere to the mask requirement will be 1 warning then **expulsion from the event without refund.**

3) When setting up your pit area for the weekend, the pond has a lot of room, so please spread-out. Also 10x10 canopies should provide enough social distance, we ask that you use your pit tables to use separation to provide a barrier to adhere to distance standards.

4) Hand Sanitization stations will be strategically placed around the area for anyone to use. We would encourage everyone to use them as much as possible.

5) Adhering to the 6' social distancing rule is a must and please limit the numbers of people gathering together to talk.

6) Hot Pit Area/starting the boat - please have a pit person start the boat with the driver already on the drivers stand prior to the start clock. This will minimize contact and the surge of people trying to get up the steps at once.

7) The Elm pavilion will be taped off with caution tape to allow only race participant into the area to further social distancing and control gathering of people.

8) Please make sure you have a cloth/paper towel in your pocket and available should you need to cough or sneeze. Please use this to cover your mouth even if you have a mask on, it's just an added preventative measure.

9) Drivers stand distancing, TWO drivers on each side will stand on the top tier of the Drivers stand with one driver's spot on the lower tier on each side to provide the required social distancing required.

10) We are trying to have a safe and fun event and if you don't think you can adhere to the required provisions please feel free to stay home.

Please be aware of your surroundings and think about what you are doing. We are trying to have a safe event and do not want to get shut down.

Let us Stay Safe and not be a statistic.
