The Drains at Large was amended on the budget to \$5,656.63 from \$5,000.00 money was taken from library fund due to the fact that will not have to pay St Johns leaving an excess of \$1,692. Motion by Kindel seconded by Roof

Budget was discussed with a couple of addition of line items. Mileage, training it will be finalized at the March meeting.

Fire Authority and MFR discussion – it was resolved to go to the City of St Johns due to the financial situation. If we maintained CAFR the budget would have to be \$110,000 to go with St Johns it will be \$40,000 a year for a 4 year contract. Supervisor Thelen thanked the fire fighters/MFR for their dedicated work throughout the years. It just comes down to dollars and cents.
