

MINOR RELEASE OF LIABILITY, MEDIA RELEASE, AND PARENTAL CONSENT

In consideration of the above-named minor being allowed to participate in the **West End Racing Children's Community Sailing summer sailing program for 2018** and related events and activities (the Program), the undersigned:

1. Acknowledges and fully understands the nature of sailing activities, both on water and land-based, and the above-named minor's experience and capabilities and believes the minor to be qualified to participate in such activities.
2. Understands that sailing activities involve risks and dangers of serious bodily injury including permanent disability, paralysis, and death and severe social and economic losses which might result not only from the minor's own actions, inaction, or negligence, but from the action, inaction or negligence of others or the conditions in which the Program takes place and, further, that there may be other risks not known to the undersigned or not reasonably foreseeable at this time.
3. Approves the above minor's participation in any and all associated Program activities during the season, assumes all risks and hazards incidental to such participation, and accepts personal responsibility for the damages following such injury, permanent disability, or death.
4. Releases, waives, discharges, and covenants not to sue and AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS West End Racing Children's Community Sailing, Inc., the Town of Provincetown, and their respective administrators, directors, officers, agents, employees, volunteers, sponsoring agencies, sponsors, and advertisers, and, if applicable, owners and lessees of premises and/or equipment used to conduct a Program activity, all of which are referred to as "Releasees," from any and all liability to the undersigned and to the above-named minor and his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations.
5. Understands that as part of our program, we may take photographs and/or make video, audio, audio-visual, digital, and/or other recordings of your child for use in our promotional and advertising materials including use on our web site.
6. Grants to West End Racing Children's Community Sailing, Inc. an unrestricted right to record the above child's name, likeness, image, and/or voice ("Personal Content") and to display and use the Personal Content for promotional purposes, in whole or in part, in all media, whether now known or yet to be invented, throughout the world in perpetuity.
7. Acknowledges that West End Racing Children Community Sailing, Inc. may edit, alter, or delete the Personal content in its sole discretion.
8. As parent or legal guardian of the above-named Program Participant, the undersigned hereby gives consent for emergency medical care prescribed by a duly licensed Doctor of Medicine or Doctor of Dentistry. This care may be given under whatever conditions are necessary to preserve the life, limb, or the well-being of my dependent.
