# **ASTRONOMICAL JUBILEE**

## PLAGUES UPON THE LAND

Prophetic Countdown to the Year of Release

'The Spirit of the LORD is on Me, because He has anointed Me to proclaim Good News to the poor. He has sent Me to proclaim Freedom for the prisoners and Recovery of sight for the blind, to set the oppressed free, to proclaim the Year of the Lord's favor ...He began by saying to them, Today this Scripture is fulfilled in your hearing.' – Luke 4:16-21

The purpose of this study is to consider an astronomical and planetary overlay of the time period counting down from the liberation of Jerusalem in 1967. The timeline will be calibrated to several Biblical connotations for multiple associations relevant to the End of Days most notably that there is a coming 'Jubilee War' at the end of the 50<sup>th</sup> year from 1967, or perhaps given a 1260-day interval leading-up to it. The timeline since 1967 that this study suggest was a Jubilee Year will show astronomically the 7 prophetic weeks of years corresponding to the Sabbath Cycles. The timeline to start out the patterns will show the 7 planets that correspond to the Menorah pattern as it relates to the Jupiter event of the comet Shoemaker-Levy.

This Jupiter event occurred in the midst of the Jubilee Year Cycle corresponding to the middle 'week' in 1994. This 'piercing' by a comet upon Jupiter, the planet of Messiah event had echoes of Calvary just as Messiah was pierced and 'cut off' the midst of the week. Based on these overlapping associations, this study suggests that there is also a reflection or prophetic pattern that alludes to the 7-fold dispensation of the Church Age having a Jubilee Year prophetic pattern and cycle to it. This prophetic pattern suggests that the Church Age has its own parallel pattern of the Jubilee 50 prophetic year countdown to the conclusion of the Great Commission. The prophetic time correlates to the 7 Churches of Asia and their 7-week allotment of prophetic time since Pentecost in 32 AD or thereabouts.

This Jubilee Year pattern constitutes each of the Churches as a 'week of time' (7+7+7+7+7+7+7 = 49) culminating in the prophetic 'Year of Release', i.e., the 'Jubilee' that could be the Resurrection and Rapture of the Bride of Christ, where simultaneously a Covenant is consummated, a Covenant is begun based on war. Why war? It is because the notion of a Jubilee has thus far been accompanied by war in Israel. The Rapture is part of this multifaceted layer of prophetic convergence of timelines that this study suggests will occur simultaneously with the Church being evacuated as YHVH then focuses on Israel. This transmittance will be as it was with the Israelites and Egypt during the time that the Plagues were unleashed upon the land and Pharaoh was judged. As the Church Age ends and the timepiece is transferred to Israel, it will be a 'release' of the final reprieve for the Bride of Christ.

#### A False Release

For Israel it will be a false sense of release due to the Covenant promising a 'Peace and Safety' that will instead be a war as it was sprung on Yom Kippur, in 1974 exactly 7 years after the September 24, 1966 Yom Kippur Jubilee Cycle. The point is that the subsequent 7-year cycles could be the initiation of the transference year or the start of it. Not the least of which this 'Confirmation of the Covenant' will not last and will be broken likewise in the midst of the prophetic week of the Tribulation Period. If the pattern is reliable and valid, it will be a mirror of itself, an end, and a beginning. The apparent convergence of timelines suggest that the coming years will be very prophetic. Initially, a false parallel will occur with Israel in how the Hebrew nation was spared the Plagues as Egypt was judged simultaneously during the Exodus and Passover.

As the time of freedom and liberty was granted to the Israelites, the nation of Egypt suffered the Plagues upon the land and was destroyed as its prideful Pharaoh was judged. In essence, it was a declaration of war, mutually by Pharaoh and YHVH. This study is suggesting that both the Church Age's end of its Great Commission of the Witness on Earth of the Gospel of Jesus Christ could be synchronized to the literal transfer of Daniel's 70<sup>th</sup> Week of Years to Israel based on the liberation of Jerusalem in 1967. It is when the 'Witness' of the Church Age is concluded that the subsequent Witness will ensue, that being of the 144,000 Anointed and the 2 Witnesses per the book of Revelation. Whether the 144,000 Anointed and the 2 Witnesses overlap remains to be seen, however this study suggest each will operated exclusively in their singular 1260-day interval.

The point is that the Church's Great Commission and Witness is also a 'Covenant'. It was made by Jesus with His Disciples at the Last Supper on the eve of Passover symbolized by the Bread and the Wine. This Covenant is the 'New Covenant' contract that also is a type of a marital contract between Jesus, the Groom, and the Disciples. Thus, the representatives of the Bride of Christ cannot overlap Israel's Covenant of Death as the book of Isaiah puts it. The coming 'Confirming of the Covenant' will be for Israel as a marriage covenant with the false Messiah. The 7-years of the Tribulation Period will be initiated by the 'Covenant with the Many' because the Church's Covenant has been fulfilled. The Jubilee Cycle is about fulfilling a Promise of a Covenant. Israel's new Covenant with the false AntiChrist will 'release' Israel and give her the 'freedom' to build its 3rd Temple but under false pretenses.

The 'freedom' in actuality will be an enslavement of not only Israel but the entire world. The promise fulfilled to the Church is that its Covenant releases the Church when it is completed as the 'Spiritual Temple'. This work has represented the Church Age throughout the prophetic 49 years of 7 Churches as Christ Jesus has been 'building' her as a 'Spiritual House'. The coming 'confirming' of a Covenant between Israel and the Many will constitute in the last dispensation wherein the Witness of the Gospel of Jesus Christ will be passed on to the stewardship of Israel as it was before the Church Age. This transition will be as it was depicted when the mantel of Elijah's power and witness was passed on to Elisha as Elijah, a type of the Church was raptured up to Glory. There are those that believe that the Jubilee Cycle and 'Covenant' cannot overlap with that of Israel's false one that is coming also, as one end, the other begins, etc.

#### The Final Jubilee?

Others believe that regardless of such speculation the ultimate Jubilee Cycle will be fulfilled at Jesus Christ's 2nd coming. Others believe that the Jubilee Year is miscalculated for various reasons. One such reason is due to the Great Sign of Revelation 12 regarding the Virgo constellation. Many believe it is foretelling and/or signaling the soon Rapture of the Church. Others believe the Jubilee is off based on the calculated years in alignment to the Stars of the Pyramids of Giza. The 2nd part of the Jubilee, as declared in Isaiah 61 is what Jesus will return to accomplish. The Bride of Christ will be witness to this at the Battle of Armageddon, at the end of the 7-year Covenant with Israel.

Regardless, if Jesus comes at the end corresponding to a Jubilee Cycle, it has to necessitate an end of a 7-year cycle, thus the Tribulation Period cannot be a mere 3.5-year duration that many assert it to only be. This study highly suggests that the countdown from the liberation of Jerusalem in 1967 will be the last prophetic Jubilee Cycle before Jesus' 2nd coming. It will be the first to occur since Old Jerusalem came under Jewish control. The following are some amazing Jubilee related day counts.

Using a 360-day year calculation Jun 7, 1967 + 49 years = 17640 days 17640 days + June 7, 1967 = **September 23, 2015** Yom Kippur

From September 24, 1966 Yom Kippur Jubilee to Sep 24, 2015 Yom Kippur end date included = 49 years exactly or 2556 weeks 5 days

The Jubilee Cycle pattern emphasis, in one sense is based on parallel Biblical patterns of the Plagues of Egypt and the subsequent liberation of YHVH's People out from the nation of Pharaoh. The timeline suggests that the Year of Release or Jubilee could coincide prophetically in a 2-fold manner. The day remains to be determined. For the Church, it could be a 'spiritual release', as in the Rapture just as the Captives of GOD's People in Egypt where released. Moreover, this event will simultaneously involve the judgment of the Nation and its Pharaoh as part of the 'Sudden Destruction' supposition. For Israel it will be not a release but the beginning of the culmination in a national judgment initiated by the Covenant with the 'Many'.

Instead of delivering 'Pease and Security' it will eventually bring bondage and the eventual Time of Jacob's Troubles. Why this is prophetically monumental is that not since 70 AD had the Temple Mount been under Jewish sovereignty. However, the administration of the Temple Mount was given over to the Muslims as an appeasement by Moshe Dayan. This study suggests that a possibly war could occur with Israel over such an issue. The issue could also involve the dividing up of Israel in the 'Land for Peace' stipulation of the Oslo Accords. To some, this is the 'Covenant' already established to be 'Confirmed' with the 'Many' that will allow for the building of the 3rd Temple as either a concession or as a spoil of a war. There could be a ~3.5 years after the 70th anniversary of Israel's 1948 statehood as a prelude to such a scenario.

As a typology of the Jubilee Year 'release' of Israel from Egypt, the 10 Plagues took 70 days to complete, if the first 7-day judgment that is given is attributed to the rest as a pattern. The Exodus from Egypt on Passover could thus be seen as a Jubilee Year type. Thus, the Year of Release could also be a type of the Rapture as Israel was 'snatched' out from Egypt. The other irrefutable prophetic events that will be touched upon are the comet collision of Jupiter and the Jubilee Pattern itself as it converges on the last 7th Sabbatical Cycle. In one aspect, the USA's independence was like a Jubilee Year of 'release' in the New World, a new nation that was birthed bringing 'freedom'. In another parallel of America to Israel, geo-politically, America had 13 Colonies as Israel had 12 but incorporated the 2 sons of Joseph, etc.

Then America was divided between the North and South as was the Kingdoms of Israel in the north and Judah in the south. On another level of interpretation, America can currently be likened to the oppressive Egypt system of the Exodus time. This will conversely be as if America is Egypt that was judged for repressing the People of YHVH. This study suggests that America has prophetically had 3 renditions of a Jubilee Year of release. For America, the 1st connotation to a prophetic 'freedom and liberty' Jubilee type was at its birth in 1776. The 2nd connotation was during its Civil War with the Emancipation Proclamation. The 3rd and last connotation deals with a Jubilee release of the Rapture of its Christians. This comparative correlation is based on the supposition of the intensified persecution of Christians in the USA that is occurring in a more sophisticated and subtle way through laws, liberal judges primarily and political correctness.

This notion of using laws from within to dismantle Christianity also has in a broader score persecution of Christians around the world, primarily in the Muslim countries. This would be hard to comprehend and reconcile as the virtues espoused by the ideals of America is what has made the nation great among the nations of the world, truly 'Out of Many, One'. In practice, the true power lies in the shadow government that directs foreign policy as its government has been co-opted by the enemies of Jesus Christ and of true 'liberty and freedom'. Such have been using the U.S. Military to push their Luciferian agenda upon the world. For example, it has been the USA led initiatives primarily at the bequest of the Luciferians requiring the wars in the Middle East to occur in preparation for their coming AntiChrist Messiah.

The justification to 'save' Christians' from the murdering Muslims in Syria and Iraq –that is ISIS is none other than an armed al-Qaida that morphed into ISIS and trained by the USA M16 and MOSSAD. These sons of Mohammed are the very ones that have been murdering, beheading, and raping the Christians. It is a prime example of a Full Spectrum Dominance operation presenting that is being presented as 'saving the Christians' of Iraq to go into Syria to actually destroy them as a collateral benefit in toppling Assad. The point being is that since most of the Christians are concentrated in the USA, the Rapture will be as a 'freedom and release' from the clutches of the coming AntiChrist, a type of the Pharaoh that knew not Joseph or his GOD, YHVH. YHVH's people found themselves in bondage to the evil and cruel Task Masters as their weapons were confiscated and were powerless to defend themselves.

## **False Flags**

If by neglect, apathy or conspiracy, the confiscation of arms to defend the Hebrews in Egypt occurred gradually overtime. During the time leading up to the Exodus in Egypt, the Task Masters were Jews, the Hebrews themselves who sold their countrymen to the 'federal' system of Pharaoh. Such were employed by the State to subjugate YHVH's People. Slowly but surely, YHVH's People found themselves enslaved to the government through labor, dependency, and taxes. It is no different now in that many Pastors of Christian congregations across American have compromised their Flocks and in reality, are no better than 'Federal Task Masters' of the likes in the Exodus account. In what way?

Many do not realize that the reason for 'membership' in a church is to obtain tax-exempt status and the 'list' is required of the Federal government. As it is now, FEMA works with Clergy Response Teams whose sole purpose is to herd their Flocks to the coming concentration camps that eventually will be set up with gas chambers and *guillotines*. It is becoming all too evident that these crisis-respond-solution events will be part of the measures needed to be put in place to handle the masses when the U.S. economy collapses and in turn tailspins the world into a need for an economic reset.

The collapse is scheduled to occur, perhaps the Rapture will be the catalyst to coincide with the advent of the chaos around the world. This 'freedom and liberty' from Christians and their Christianity will bring the judgment upon spiritual Egypt, i.e., the USA and the world. The New York Stock Market controls the world's economies through their Central Banks and 'shadow governments'. Perhaps as the USA began, it will end its hegemony over the nations as was Egypt. The nation's economy that was the breadbasket of the ancient world collapsed as the true 'freedom and liberty' of YHVH's People occurred simultaneously. The following are some unique Sabbatical Year Cycles counts related to the Yom Kippur War of 1973 that appear to synchronize to a possible prophetic event in 2022.

From September 24, 1966 Yom Kippur = Jubilee to Oct 06, 1973 = ~ 7 years

From Yom Kippur October 6, 1973 + 49 solar years = Yom Kippur of October 6, 2022

From September 23, 2015 + 7 years = 2022

There were 7 years from Yom Kippur September 24, 1966 to the Yom Kippur War in 1973. Thus, if there was a 7-year period from 1966 to the Yom Kippur of 1973 that saw a war. Then the 7 years from 2015 saw ongoing conflicts likewise or an escalation in the Middle East. The 49<sup>th</sup> year ending in 2022 started on Yom Kippur 1973, and thus the 50<sup>th</sup> year would coincide with 2023. The 7-year cycles have corresponded to the major Stock Market crash cycles. The Bible teaches that the coming AntiChrist will have the economic monopoly controling the world as the evil and crewel Task Master in Egypt.

#### The Evil Task Master

The AntiChrist type, that being the Pharaoh of the Exodus has begun to be judged by the Plagues now unleashed upon its kingdom. If the Biblical narrative plays-out, then likewise, the Bible portrays the Beast that will harden his heart for the devastation and judgments decreed for the treatment of YHVH's People. As it was then, it is even now how Pharaoh wanted population control and forced 'abortions' upon YHVH's people, among other things like gun confiscations. For example, concerning the USA, many believe because of the abortions upon the land since Roe vs. Wade, judgment of America will come eventually. It is estimated that in the USA alone, more than 70 million unborn babies have been aborted or murdered. Thus, only as a type, perhaps YHVH's People will see this prophetic Jubilee type in the form of the 'Release' as the Rapture.

This would then coincide with the nation being destroyed much like Egypt was because of this sin of Egypt. The USA is like Egypt even topographically. One could consider the Mississippi river and its delta as a mirror of the Nile Delta. As the Nile runs to the sea going northward, the mighty Mississippi runs southward off the same latitude. All along the Mississippi, one will find the same names as those in the Nile River region. The most prominent city would be that of Memphis where there is actually a pyramid at the edge of the river. The rivers of each nation are also geographically approximating a phi ratio proportion of the land as in the USA's case from coast to coast. America has a peculiar history of making Covenants with the All Mighty, foremost with the Declaration of Independence related to 1776 and the Liberty Bell. George Washington consecrated the new nation at Ground Zero in New York City by a Covenant, etc.

It was at this precise place and end of the Sabbatical Cycle that the Covenant with America was attacked on 9-11. Currently for America, there is a battle for her soul. The contention is over which Covenant will prevail, YHVH's or Lucifer's through the Masons 'Great Work' for example. Later on, President Lincoln signed the Emancipation Proclamation that like a Moses, released approximately 3 million African slaves as a Covenant. It was signed on the 88<sup>th</sup> year since the July 4<sup>th</sup>, 1776 Emancipation of the USA from England. This 3 million number approximated the same number of the Hebrews that were slaves and released or emancipated by Moses in Egypt. Thus, it is not a stretch of the imagination to associate the coming Rapture of the Bride of Christ will have a profound effect upon the world, but more precisely on the USA.

As to Egypt, are the People of YHVH, oppressed spiritually for the most part is about to be released, as in the Rapture? Consider that most would agree that the highest concentration of Christians is in the USA. These attributes of the coming judgment upon the land are but a glimpse into the spiritual contention between the light and the darkness, those that wish to enslave and subjugate and those that wish to pronounce 'freedom and liberty'. What is also becoming clear is that the American people themselves in general have been conditioned now to be intolerant of Christian ideals and principles as they are equated with bigotry, homophobia, and racism. It has gotten to the point that if preachers associate such activities as abortion, illicit sexual practices, deviant definitions of marriage, etc., as sin, it is a hate crime and punishable by prison. What is light is now darkness, what is good is not bad, etc.

## Judgment upon the Land and of its Pharaoh

This study is suggesting that the Rapture event could thus be based on the Biblical patterns to either correspond to a Feast, an eclipse event, a Pentecost timeframe. Nonetheless, the 'season' of the Rapture has arrived and appears to be a convergence of prophetic timelines and it will be a prophetic milestone for Israel that could signal such events either leading up to it, or soon after. There will be 3 possible seasons that the Jubilee patterns for a Rapture event points to as only a type and shadow. The 1st pattern would be on a Passover as the Israelites were liberated and left Egypt on the last Plague that was pronounced. The 2nd date would be Pentecost as the 49th year leads-up and corresponds to the 50th day that involves the birth of the Church, set free for the Great Commission.

This time and type also correspond to when the Israelites reached Mount Sinai. The Covenant of Marriage, of the Law was ratified and implemented between Israel and YHVH. As to the Church Age, it has had its own 49 prophetic Jubilee count of 7 weeks of 'dispensations' relative to the 7 Ages pertinent to the 7 Churches of Asia. Perhaps the last Church Age of Laodicea will witness the final 7-year Prophetic Week and end of the 49th year Great Commission to be completed soon. This 7-fold Witness of the Church's Great Commission has occurred since Pentecost but in 'bondage' prophetically speaking like the Israelites where in Egypt until the last prescribed day was fulfilled. As the Israelites, the Church is still in the domain of 'Egypt', the land of the 'Spiritual Pharaoh', Lucifer the 'God of this world'.

The 3rd and last pattern is at a Yom Kippur itself as this is the date in which the Jubilee was pronounced by the High Priest going into the Temple Holy of Holies to propitiate the blood as there was 'silence for ½ hour'. This Yom Kippur feast as a type and shadow is exactly what is occurring in Revelation 4 when John is summonsed behind the curtain before the Heavenly Holy of Holies and YHVH's Mercy Seat. Thus, could the Rapture follow this same sequence and timing? The Jubilee timeline down here on Earth as it pertains to time and space also has an 'echo' of Calvary in a 2-fold manner. One, the planet Jupiter corresponds to the Messiah with the comet collision that occurred in 1994, the middle year based on a Menorah pattern of years spanning the prophetic Pentecost period. Messiah was crucified on Passover in the midst of the week, Wednesday.

Then 49 days after His resurrection, the Holy Spirit was 'released' to the Church on Pentecost. This 50th day span parallels the 50th year timespan of the Jubilee. This study suggests that as the liberation or 'release' of the Temple Mount that was secured during the 6-Day War on Pentecost, perhaps the Rapture will ensue a prophetic 'release' of YHVH's 'Spiritual Temple', i.e., His Bride of Christ in similar way during a Pentecost season. This could allude to the Rapture of the Bride of Christ as was Israel, the Bride of YHVH released from the bondage of Pharaoh in Egypt although that release corresponded to a Blood Moon Passover. As far as the Church Age is concerned it could parallel such a pattern in time with a countdown from the Blood Moon Passover and then a 50<sup>th</sup> day thereafter on the Heavenly Mount Zion consummating the marriage of the Bride of Christ. The opportunity of such a possible Blood Moon pattern of Passover to Pentecost is yet to be determined.

#### **Astronomical Rapture**

This study is not insinuating that at that time the countdown to a Pentecost will constitute the Rapture event or on a Blood Moon for example. However, the birth of the Church on Pentecost was directly associated with celestial Signs of the Sun and the Moon by none other than Peter. Thus, a Blood Moon and/or a particular eclipse could be very significant. For example, there is a unique Central Blood Moon in 2018 just after Pentecost on the 70<sup>th</sup> year anniversary of Israel's rebirth. As the Blood Moon of the 1<sup>st</sup> Passover in Egypt and the corresponding one on the 14<sup>th</sup> of April 32 AD was about a divine judgment and release.

Will a coming Blood Moon or eclipse bring such an omen against the 'Land' of a prelude to a coming judgement and release; perhaps a coming Rapture? This study does take the position that the Bride of Christ will be released before the Wrath is to come with full vengeance and that it could coincide with a war in Israel. This condition for 'Freedom and Liberty' did not occur for Israel nor has. Astronomically, what this study is presenting is that the entire 49-year period is also pegged to eclipse patterns that are amazingly symmetrical and correlate to the Menorah pattern of 6 arms and 1 stem. The bookends are the Temple Mount and what this study strongly suggests based on the prophetic pattern is that the 3rd Temple event is to occur.

This is based on the reverse judgment upon the Temple, the City and the Nation as disclosed by the LORD Jesus on the Mount of Olives. Pictorially, the center stem corresponds to the Milky Way, vertically with Jupiter as the center stem. What is very peculiar is that astronomically the Jubilee 49-year pattern is bookended by Tetrads. The focal point or center year is 1991 which is a mirror of itself even. They occur also at the phi ratio proportions and when mirrored to 1994 as opposites. The Tetrad of 1967-68 was associated with Mercury at its beginning of the pattern as the Tetrad of 2014-15 is associated with Uranus at its end.

This planetary pattern exactly matches the order of the planets, each corresponding to the color spectrum and peculiarly Jupiter as the 'Planet of the Messiah' that corresponds to the center stem. This position would correspond to the Servant Stem and the year 1994. The center stem year of 1994 that astronomically correlates to the planet Jupiter is the year in which Jupiter was pummeled with comet Shoemaker-Levy. This to many was a prophetic sign to Israel and the world of pending 3-2-1 judgment as the event that is associated with the planet of Messiah had echoes of Calvary where Jesus on the Cross, as a 'Jupiter' was pierced by YHVH's complete judgment in the midst of the Passover Week.

It was on July 17, 1994 on the 9th of Av that the comet collided with Jupiter. The 9th of Av was also when the 1st and 2nd Temple were destroyed and thus as a type, the body of Christ Jesus, whom He said was a Temple at Calvary was 'destroyed' but rose on the 3rd day per the Sign of Jonah. As it has been noted, the context of this time frame could be the 'Peace and Security' many are extoling even now but could be a disguised war the Muslim enemies of Israel have been preparing. When the Hebrews were released from Pharaoh, from the Plagues, the People were bestowed with its plunder.

## The Spiritual Exodus to Come

If the Exodus pattern is indeed prophetic then it will be Israel that will stand to obtain a spoil of the coming War against its Muslim enemies as described in the Psalm 83 War scenario. For the Bride of Christ, this would simultaneously perhaps encompass the Rapture and subsequent rewards at the Bema Seat of Christ where she will be bestowed the 'Riches of Heaven', etc. As to echoes of Egypt, Great Pyramids and Pharaohs, there is an interesting esoteric painting that depicts a woman in a portal or 'gate' being 'raptured' up. This painting is at the Bank of America in Charlotte, N.C. The event coincides with a total solar eclipse and a comet intersecting the same time period.

Shoemaker-Levy Comet and 'the String of Pearls'
Comet broke up in exactly 21 pieces, a picture of as if a lance piercing the planet
(7+7+7) = 3 Sabbatical cycle or 1994 + 21 year = 2015 or start of 5776 'Year of Light'

From June 7, 1967 to Yom Kippur on September 23, 2015 = 48 years, 3 months, 16 days or 2520 weeks

49 years x 120 Jubilees = 5880 years 5880 years – 6000 year dispensation = **120** years 120 year limit x 50 year cycles = 6000 years

The context is Egypt with Pyramids in the background as in the possible Year of Release from bondage and Pharaoh's people that seem to congregate to behold the 'Manchild' of sorts. As the 'Bride' is at the background, bound, the Manchild is being introduced to the forefront to prominent world leaders, much like an Obama, Trump and Hilary personages. Like the Hebrews of Egypt, one day she will be released perhaps to coincide with a day or season where such 3 personages coexist, that of Obama, Hilary and Trump? Some attribute this depiction of the coming and the unveiling of the Prince AntiChrist. This false Prince is to rule the New World Order or Daniel's last rendition of the 4th Beast made up of 10 Horns from which this 'Little Horn' arises from.

In particular, there is a Jubilee and Rapture theme in the constellations that depicts such a bondage and deliverance to take place. Astronomically Andromeda typifies the current Church Age of the Bride of Christ, although in Christ Jesus, she still is in bondage. It is in the sense that she is behind enemy lines, in the land of 'Spiritual Egypt' with Pharaoh or Lucifer as his evil Task Masters that are allowed to persecute the Church. The 'Chained Woman' is attached to Pegasus which signifies, 'deliverance comes swiftly' according to the Biblical interpretations of E.W. Bullinger.

Pegasus is a horse with wings that alludes that the 'Chained Woman' will take flight at her 'rapture' time of release from the bondage of the Earth and its 'Pharaoh'. The Bride of Christ will be transformed as she is taken to the Pavilions of YHVH's Temple in Heaven where she will sit next to the King of the Universe as the Court in Heaven comes into session to open up the Seal Judgments to commence the Wrath of the Lamb, all inclusive. At that point Andromeda, once bound but released is transformed into the 'Enthroned Woman', Cassiopeia that will witness the breaking of the 7-7-7-fold Seal Judgment against her Accuser, Lucifer.

#### The Deliverance

Astronomically, Cassiopeia typifies the future state of the Bride of Christ, Jesus released from bondage. She takes her seat in the Court of Heaven as the type of the 24 Elders. This scene is shown to Daniel in chapter 7 and John in the book of Revelation. She will be next to the King of the Universe that will be in session to adjudicate the Bride and sentence the Dragon, Lucifer legally out of Heaven, that will be cleansed as a type of Leaven from the House and expelled to his eventually destiny of the Lake of Fire. This event coincides with the War in Heaven of Revelation 12 and casting down of Lucifer to Earth, etc. The timing of the Blessed Hope, the Rapture is to be a blessing for YHVH's People. It was an anticipation of hope, of 'Freedom and Liberty'.

It is not a double jeopardy of having to yet endure the Wrath of GOD during the Tribulation Period. Where is the 'blessed hope' in that? Such was the prescription of Exodus with Moses and the Kings of Israel within the Promised Land. Ultimately, the greatest Exodus will be the Rapture, as a type came in part when the prophetic time coincided with the birth of Messiah. The literal prophetic fulfilment of the 'Exodus' from sin started with His public ministry. Jesus proclaimed the Year of Jubilee to be fulfilled in the hearing of the Elders of Zion as Jesus read the Tanakh or Torah in the synagogue of Nazareth, not the Talmud. This Jubilee would be the year of release from Humanity's sin condition and bondage to Lucifer. Sadly, for YHVH's People, they rejected Jesus and thus their opportunity for their Jubilee that is spiritually foremost from sin, death and the type of Pharaoh that Lucifer is.

Israel as before, stubbornly refused YHVH's precepts and rather chose to go into captivity and in bondage as with the Diasporas. Thus, Israel was judged instead at the hands of the Romans and exiled to the Nations. Based on some interpretation of End Times, Jesus alluded to there still being a future time to finish Israel's punishment and an ultimate Jubilee at Jesus Christ's 2nd coming at the Battle of Armageddon. Based on the year count, the 2nd coming of Jesus will not technically be a Jubilee but only in principle as Israel is rescued by Jesus, their Messiah from the assault of the AntiChrist as Jerusalem is surrounded. Some believe that the Rapture of the Bride of Christ will correlate with the unfinished prophetic Sabbath cycle of Daniel's 70th Week.

This is not taking into account any 'gap theory' or a possible 3.5-year lull in preparation for the time that will constitute the 7-year Tribulation Period with the last 3.5 year or 1260 days of the Time of Jacob's Trouble. In prophetic 'time', what the study has suggested is that the Rapture is the benchmark that started as a countdown from the year of Jerusalem being liberated from the Muslims in 1967. There is also the astronomical Sign of Jupiter's collision with the 21-piece broken-up comet. Many are attributing this 21 piece or a 7-7-7 code cycles of years that will commence the last one that could be Daniel's last prophetic 70th Week of Years to finish the punishment of Israel for rejecting YHVH's Jubilee, and their Messiah, Jesus Christ. The multiple convergence of timelines points to the soon arrival of the release that could affect the Church and Israel in a most profound and prophetic way yet to be fully determined. This event would surely signal that the transference of the Royal Commission of the Church Age Saints has been completed.
