

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY  
TO THE TOWN OF CLOVERDALE, INDIANA.

SECTION I: Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana, to wit: Situated in that part of Clark's Place (Clark Addition) to the Town of Cloverdale, Indiana and recorded in Plat Book ~~22~~ 132, and as more specifically described as to wit: Lots 1 thru 26 which embraces Sections 31 and 36, Township 13 North, Range 3 West in Block 1; Lots 1 thru 18, Section 31, Township 13 North, Range 3 West, Lots 7 thru 12, Sections 31 and 36, Township 13 North, Range 4 West, Part of lots 6 and 13, Sections 31 and 36, Township 13 North, Range 3 West, Lots 1 thru 14, Section 31, Township 13 North, Range 3 West, Lots 7 thru 12, Sections 31 and 36, Township 13 North, Range 3 and 4 West, Part of lots 6 and 13, Sections 31 and 36, Township 13 North, Range 4 West in Block 4; and Martin Addition to the Town of Cloverdale, Indiana and recorded in Plat Book ~~3~~ 3, Page ~~116~~ 116 and as more specifically as to wit: Lots 5 thru 12, Section 36, Township 13 North, Range 4 West. Also the following described real estate as to wit: A part of the East half of the Southeast Quarter of Sections ~~M 31~~ M 31, Township 13 North, Range 3 West, and described as follows, to wit: Beginning at a point on the North and South ~~LINE~~ Section Line dividing Sections 36 and 31, 1151.52 feet South of the Northeast corner of the Southeast Quarter of said Section 36; thence West 270.7 feet to a point, thence South 125 feet to a point; thence East 10 feet to a point; thence South 388 feet to a point; ~~thence East~~ thence East which point is 260.7 feet West of the said North and South Section Line; thence East 435.6 feet to a point on the West right-of-way line of Indiana State Highway #43, said last mentioned point also being 175 feet East of the said North and South Section Line, and 1664.52 feet South of the Northeast corner of the East half of the Southeast Quarter of said Section 36; Thence Northwestwardly parallel with and adjacent to the West right-of-way line of Indiana State Highway #43, to a point on said West right-of-way line, said last mentioned point being 150 feet East of, and 1276.52 feet South of the said Northeast corner of the East half of the Southeast Quarter of said Section 36; thence Northwardly parallel with and adjacent to said right-of-way line of Indiana State Highway #43, a distance of 131 feet to a point; said last mentioned point being 125 feet East of and 1151.52 feet South of the Northeast corner of the East half of the Southeast Quarter of said Section 36; thence West 395.7 feet to the point of beginning. Containing 4.88 acres more or less.

SECTION II: That this ordinance shall be in full force and effect from and after the passage and legal publication thereof according to law.
