Any deviation of these rules and regulations will result in an immediate disqualification. WoO Craftsman Late Model Series reserves the right to alter show format and revise race procedures in the event of, but not limited to, car count, inclement weather, challenging track conditions and/or other extenuating circumstances. WoO Craftsman Late Model Series will enforce and govern all competition, mechanical, procedural, technical and tire regulations and rules.

- Promoters reserve the right to refuse any application at any time and to close entry once they deem the number of entrants to be sufficient.
- All cars will be subject to WoO Craftsman Late Model Series control from the time they enter pit area until they are officially released after the race.
- Only tow vehicles will be allowed inside pit area. Each Competitor will receive a FREE Camping pass when you have pre-entered for the event.
- Work area vehicles (ATV/Gator/Mule/or similar) will be permitted in the Pit Area. Each team will get one (1) full access pass for a work area vehicle if you pre-enter. ***There will be a \$25 charge for all additional work area vehicles that leave the pits.** * Any other work area vehicles that remains in the pit area will not be charged.
- NO RIDERS ON WORK AREA VEHICLES AT ANYTIME**
- Driver One-Way Radios are mandatory. AMB scoring transponder rental is included in entry fees.
- Tire rule: Hoosier LM20, LM 30, on all four corners and a LM40 RR Option.
- All prize money will be issued from WoO to designated payee. Checks will not be issued without a verified IRS Form W-9 on file. All entrants are participating on their own behalf and are completely independent of the event organizers. As an independent contractor, entrants are assuming all responsibilities for prize money received including all income and withholding taxes that apply to such winnings.

World of Outlaws Craftsman Late Model FORMAT & ADVANCEMENT (EACH NIGHT)

Thursday and Friday: Up to six heat races, and up to three Last Chance Showdowns

Saturday: Event Heats will be set by the best finish of the driver in Thursday and Fridays 30 lap Features. Up to six heats and three Last Chance Showdowns. The top non-transfer cars in the Last Chance Showdowns will be eligible for the “Uncle Sam 30”

PROVISIONALS: The two drivers highest in WoO Championship standings that do not qualify for the Feature will be granted positions 23 and 24. Up to two local additional provisional’s for Saturday Firecracker 100; top Lemerville point driver not qualified, winner of “Mid-Season Championship” Emergency Provisionals may be given to WoO Series Regulars.
