22 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

- 23 1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which
24 appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership
25 Order”).
- 26 2. Pursuant to this Court’s *Order Re: Petition No. 1*, the Court approved the
27 Receiver’s compensation at the rate of \$250.00 per hour together with all reasonable costs

1 and expenses incurred relating to these services as Receiver. These services are billed by and
2 paid to the Receiver's firm, Simon Consulting, LLC.

3 3. Pursuant to the *Order Re: Petition No. 1*, the Receiver has engaged the services
4 of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver has
5 agreed to pay the law firm compensation at agreed hourly rates for the services of the firm
6 together with all reasonable costs and expenses incurred on behalf of the Receiver.

7 4. Pursuant to this Court's *Order Re: Petition No. 2*, the Receiver is authorized to
8 file this fee petition without including as exhibits the itemization of services rendered to, and
9 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
10 includes a statement that anyone desiring additional information concerning the services and
11 costs to be paid under the fee petition may obtain redacted information from the Receiver by
12 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
13 written request specifying the additional information requested at least three (3) days prior to
14 the date set for any hearing on the fee petition. The *Order Re: Petition No. 2* further provides
15 that upon request of the Court, the Receiver shall make available for in camera review by the
16 Court the itemized statements and supporting documentation for the services and costs to be
17 paid under the fee petition. Pursuant to the Court's Minute Entry dated June 3, 2021, the
18 Receiver has submitted the itemized statements for "In Camera" review.

19 5. The Receiver has submitted an itemized statement for services rendered to this
20 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable
21 costs incurred or paid during the period of February 1, 2022 through February 28, 2022. The

1 total amount requested for payment by the Receiver is \$1,333.00. The Receiver believes that
2 this amount is reasonable and should be paid from the Receivership Assets.

3 6. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
4 statement for services rendered to this Receivership and for reimbursable costs incurred or
5 paid during the period from February 1, 2022 through February 28, 2022. The total amount
6 requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$2,838.02. The
7 Receiver believes that this amount is reasonable and should be paid from the Receivership
8 Assets and has therefore approved this statement for payment.

9 WHEREFORE, the Receiver respectfully requests that the Court enter an order
10 authorizing the Receiver to pay from Receivership Assets:

11 1. The amount of \$1,333.00 to Simon Consulting, LLC, for services rendered and
12 costs incurred or paid during the period February 1, 2022 through February 28, 2022; and

13 2. The amount of \$2,838.02 to Guttilla Murphy Anderson, P.C., for services
14 rendered and costs incurred or paid during the period February 1, 2022 through February 28,
15 2022.
