RESOLUTION NO: SL – 79 - 2020

TITLE: Approval of Environmental Review Policy and Procedures

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statute 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

WHEREAS, the 2020 Indian Housing Plan (IHP) states the Summit Lake Tribe will provide the Tenant Based Rental Assistance Program, Down Payment and Closing Cost Assistance Program, Rehabilitation Assistance to tribal members and a Model Activity for Acquisition of a new building; and

WHEREAS, Policy Handbooks for the Housing Program were created by the Tribal Council and staff to provide the personnel responsible for the Housing Program with an outline for program implementation; and

WHEREAS, the Housing Program Manager proposes to the Summit Lake Paiute Council an Environmental Review Policy and Procedure; and

WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt the Environmental Review Policy and Procedure to ensure compliance with the Indian Housing Block Grant (IHBG) Funding; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby approves the adoption of the Summit Lake Paiute Tribe’s Environmental Review Policy and Procedure.
