After asking he admitted to bringing a bigger truck than previous years that was unable to get down close to the water.

how long there was between the start of registration and the start of fishing. We will look into adjusting this parameter for next year. Also, two new fish measuring boards were purchased which will need reimbursed along with the prizes purchased for the winners. Additionally, the college (Penn West California) did send two student volunteers, though one left by 9:15AM.

We will better organize the prizes of the event, and look into having loaner fishing rods for those who want to participate but don't have their own gear.
