

## PRIVACY POLICY

This Privacy Policy discloses the privacy practices for the [grantedwish.org](http://grantedwish.org) site and various related services together referred to as the "site". The Granted Wish Foundation, the provider of the site (referred to as "us" or "we"), is committed to protecting your privacy online. Please read the information below to learn about our practices regarding your use of this site.

You acknowledge that this Privacy Policy is part of our Site Terms of Use, and by accessing or using our site, you agree to be bound by all of its terms and conditions. If you do not agree to these terms, please do not access or use this site.

We reserve the right to change this Privacy Policy at any time. Such changes, modifications, additions, or deletions shall be effective immediately upon notice thereof, which may be given by means including, but not limited to issuing an e-mail to the e-mail address listed by registered users and posting the revised Policy on this page. You acknowledge and agree that it is your responsibility to maintain a valid e-mail address as a registered user, review this site and this Policy periodically and to be aware of any modification. ### Types of Information Collected

In order to better provide you with our products and services, we collect two types of information about our users: Personally Identifiable Information and Non-Personally Identifiable Information. Our primary goal in collecting information from you is to provide you with an effective and efficient experience while using our site.

**Personally Identifiable Information:** This refers to information that lets us know the specifics of who you are and how you may be contacted. When you engage in certain activities on this site, such as filling out online forms, we may ask you to provide certain information about yourself. It is completely optional for you to engage in these activities. If you elect to engage in these activities, however, we may ask that you provide us personal information, such as your first and last name, mailing address, e-mail address, telephone numbers, and other personal identifying information. When ordering products on this site, you may be asked to provide a credit card number. Depending upon the activity, some of the information we request is identified as mandatory and some as voluntary. If you do not provide the mandatory data with respect to a particular activity, you will not be able to engage in that activity.

**Non-Personally Identifiable Information:** This refers to information that does not by itself identify a specific individual. We gather certain information in several ways, based upon which areas of the site you visit. This information is compiled and analyzed on both a personal and an aggregated basis. This information may include the website's URL that you just came from, which URL you next visit, what browser you are using, and your Internet Protocol (IP) address.

### Collection, Use, and Release of Information

We do not collect any Personally Identifiable Information about you unless you voluntarily provide it to us. You provide certain Personally Identifiable Information to us when you input and submit your information through our online forms.

We will primarily use your Personally Identifiable Information to provide our services to you. We will, from time to time, send you e-mail regarding our services.

Information you provide to us is used for its intended purpose and may be shared with other outside agencies, organizations, or individuals without the customer's permission. ## **Security of Information**
