Regular Meeting ---- March 9, 1988

The meeting was called to order by the Clerk, Neal ATTENDANCE Dalton at 7:00 P.M. in the District office. Other Board members present were Dan Holyoak and Linda McKinney.

Others present were Roberta Highland and Dale Pierson.

Roberta Highland read the minutes of February MINUTES Dan moved the minutes be approved as read. Linda 10,1988. seconded. MOTION CARRIED.

Pierson reported that during the past few weeks, GRANT APPLIthe city has asked for clarification of Public Drinking CATION FOR NEW Water's regulation, that that has now been forthcoming, and CULINARY WATER he has told Bedke to start preliminary work on the All Ameri-LINE can Acres culinary water line. The project was discussed briefly.

The January and February financial statements were FINANCIAL STATEMENT handed to those present and briefly discussed.

The notice inviting bids for the meter reader was METER READER discussed, and the job descriptions gone over. It was agreed BIDS that the bids would be opened at the April meeting, and if necessary from a reading of the bids, a special meeting could be called to interview applicants.

The map to Gary Holyoak's property was examined and GARY HOLYOAK it was agreed to negate the sewer billing to that property SEWER BILL because of lack of easement. Disposition of the \$600.00 previously paid by Holyoak was postponed to the next meeting.

Dale reported that in early February the church had BOBBY BROOKcalled Dale, about a leak at Bobby Brookshier's meter. Dale SHIER MATTER and Kim went out and looked at it and decided to let it go until the next day because of the cold. At 10:00 the church had called again, saying the water was rising. When the pit was pumped, it was discovered the hole was on her side of the meter, and we had averaged her use for the past two years, and and subtracted that amount from her reading at that time, which would make a 14,000 gallon adjustment on her bill. The Board agreed.
