

### From the President's Desk... Loretta K. Donlon

#### Is There a Felony in a Teacher's Future?

"Teachers in Florida are emptying classroom libraries to avoid going to jail." So reads a headline from 'Vice' news. Splashy and shocking but true. It appears teachers could be charged with, "...felonies for exposing students to books considered 'prurient' or 'offensive,' according to the article. Now, teachers generally have gone by the term age appropriate when ordering books for their classroom and the state curriculum. Also, many of those books have been approved by the school board. In fairness, it could be argued correctly that the state and school boards have a right to decide what goes in that classroom.



According to 'Vice,' "In the first month of 2023, 17 bills have been proposed across 13 states that would allow for civil and criminal prosecution of librarians, educators, higher education faculty, and museum professionals." The article opines that a flood of such legislation could limit students' abilities to think critically. Much of these laws have been promoted and financed by an organization called, Moms for Liberty. This group also has been effective in electing school board candidates who propose rules and legislation such as the one in Florida.

As retired teachers we are still interested in the pedagogy of the classroom, and we should have a vested interest in seeing children become critical thinkers. In the past some of us may have had books challenged by parents. Usually there was an established school board policy. Perhaps it was a committee of teachers, a librarian, and an administrator, possibly parents. The issue of the book's appropriateness was examined, and a recommendation given. Perhaps the findings went to the school board for a final decision. But, in none of these instances, usually was a teacher or librarian subject to civil or criminal felony charges.

This Florida law and others is part of a continuing attack on teachers and public education. But we have an answer. NYSUT's Vote-Cope is our voice in Albany and Washington. And it supports legislators and school board members who understand and respect the judgement of teachers. It supports not only full funding of schools and the health and welfare of its members, but their ability to teach a generation of critical thinkers. So, if your in-service local or NYSUT directly asks for an increase in your Vote-Cope contribution, please give. Not only will you benefit, but you are paying it forward to students and teachers alike. Your donation may prevent a felony in a teacher's future!

#### The Governor's Proposed Budget Is Out, Hooray?

**Well, yeah, kinda.** Governor Kathy Hochul's executive budget hit recently. There is much to celebrate. Fair and full funding for K-12 public schools; fulfilling the 3rd year promise. Money for the expansion of universal pre-kindergarten and affordable childcare for working families. Workforce development to help provide alternate paths for students to lifelong employment in good paying jobs and initiatives to expand affordable housing. Infrastructure, community development, mental health supports. Good stuff, right?

**So, why the "meh"?** Well, it's not what's in - it's in what's missing. While K-12 schools see appropriate funding (thank you Vote-Cope), SUNY and CUNY colleges and public hospitals continue to struggle. Despite the opportunities provided by our public colleges and the superhuman efforts of hospitals like Upstate they are at the lowest level of state funding in decades. While our schools are on the cusp of providing the wrap-around mental health and social services kids and families need - we see unsupervised and unaccountable charter schools poised to bleed money from public schools that are working. As we see preschool and childcare recognized as vital - we see programs and services for preschoolers with disabilities languishing and closing. And, finally, as we see teachers and school workers hailed for their dedication and hard work - we find the state unwilling to address the teacher shortage by continuing to penalize new staff with the unfair burdens of Tier 5 and 6.

What do we do? Well, what we do best - standing up and speaking out! Connect with the Governor, Assembly and Senate members via the NYSUT MAC app, attend Assembly and Senate town hall meetings, call their offices to tell them what they're missing in the budget- and that we vote. - *Phil Cleary, NYSUT PAC, RC 7 Board Member*
