DEMOLITION, REMODELING OR ALTERATION REQUIREMENTS

Asbestos Inspection Report Required

State and Federal regulations require an asbestos inspection of all commercial and public buildings that are considering remodeling, alteration or demolition work. The inspection and testing must be performed by and "asbestos inspector licensed in the State of Illinois".

The City of Edwardsville will not issue a building permit nor allow any demolition work until the "<u>required asbestos inspection</u>" of the proposed area of remodeling, alteration or demolition is completed, and a copy of the Illinois licensed inspector's report is given to the Building Official.

Filing State Ashestos Project Notification Forms:

It is the responsibility of the owner/contractor to file with the Illinois Environmental Protection Agency (I.E.P.A. – 217/785-2011) or Illinois Department of Public Health (I.D.P.H. – 217/782-3517) a "State of Illinois Demolition/Renovation/Asbestos Project Notification Form" as applicable (see attached).

Basic Regulatory Tips:

- All commercial and public buildings that are considering remodeling or demolition must have an asbestos inspection by a licensed professional and file an Asbestos Notification Form with IDPH and IEPA and/or Cook County addressing asbestos concerns prior to any work being started (even if asbestos is not present).
- If removal of asbestos containing materials is deemed necessary by the licensed inspector, all removal must be conducted by a licensed abatement professional.
- A property that was formerly used for a commercial or public use or that will be used for a commercial or public use must follow the asbestos regulations (ex. warehouses remodeled into apartments or a residence being demolished for a church parking lot.
- All properties being burned for firefighter training must be inspected, notifications filed and all asbestos removed by a licensed professional prior to the training exercise.
- Residential properties under 4 units are not subject to the asbestos regulations (unless being renovated or demolished for commercial or public use), however, the risks remain and owners and contractors may be cited for causing harm to the environment for mishandling asbestos containing materials. Inspection and notification requirements do not apply. Use of a licensed abatement professional is not required but is strongly recommended.

STATE OF ILLINOIS DEMOLITION/RENOVATION/ASBESTOS PROJECT NOTIFICATION FORM

Projects greater than 3 sq./it and/or 3 linear ft. and all school projects shall be submitted to Illinois Department Public Health.

Projects greater than 160 sq./ft or 260 linear ft., or 1 cubic meter and demolition projects shall be submitted to Illinois Environmental Protection Agency.

All projects in Cook County must notify Cook County Environmental Control.

This form and appropriate fee shall be submitted for all original notifications to IDPH (no fee), IEPA (\$150), and Cook County (\$200). This form shall also be used for revisions to the IEPA and IDPH. A Cook County Revision Form must be used to cancel an asbestos permit.

Dear Sir or Madam:

The State of Illinois has recently passed new legislation requiring a fee of \$150 to be paid to the Illinois RPA with each initial 10-working day notice required to be filed to perform remediation or demolition of asbestos-containing structures as required by the federal asbestos National Emission Standard for Hazardous Air Pollutants. (See 415 ILCS 5/9.13, Illinois Environmental Protection Act) This fee is effective July 1, 2003, and all notices postmarked on or after July 1, 2003, are subject to this fee.

This fee is required for initial 10-working day notification filed with the Illinois EPA and includes regular notices, emergency notices, ordered demolitions, and annual notices. Revised and courtesy notices do not require a fee. The fee must be submitted, along with the notification, by company check, personal check or cashter's check. Cash or credit card will not be accepted. Make checks payable to Illinois EPA and make notation that it is for asbestos fees.

Please note: In the event that the fee payment is from an account with insufficient funds to cover the fee. the 10-working day notice shall be deemed improperly filed, and the owner or operator of the site is subject to enforcement for failure to properly file the initial 10-day notification.

The fec is doubled to \$300.00 if the demolition or renovation of a site has commenced without proper filing of the 10-working day notice. This additional fee does not preclude the Illinois EPA or Amorney General's Office from pursuing enforcement action against the owner or operator for failure to file the 10working day notice or other violations of asbestos NESHAP or the Illinois Environmental Protection Act.

This legislation also prescribes where asbestos remediation or demolition activities have not been conducted in accordance with the asbestos NESHAP, the Agency may, in addition to the fee, collect its actual costs incurred for asbestos-related activities at the site, including sampling, sample analysis, remediation plan review and activity oversight.

REQUIREMENTS FOR OWNERS AND CONTRACTORS DURING RENOVATION OR DEMOLITION ACTIVITIES AT PUBLIC OR COMMERCIAL BUILDINGS

The National Emission Standards for Hazardous Air Pollutants (NESHAPS) is a Federal regulation under the Clean Air Act which has certain requirements for public and commercial building Owners and Contractors who are performing work in such buildings. Privately owned homes and apartments with four or less units are exempt from the regulation unless the building has had either previous use or future planned use as a commercial or public facility.

The NESHAP regulation requires Owners and Contractors to perform inspections for asbestos containing materials utilizing accredited inspectors prior to any renovation or demolition activity. During the inspection, all materials suspected to contain asbestos that may be disturbed must be sampled by the inspector or analysis by an accredited laboratory.

The NESHAP regulation further requires that a notification be submitted to the Agency, either postmarked or hand delivered, at least ten working days prior to the start of those projects in which at least 160 square feet and/or 260 lineal feet of RACM will be removed and for all demolition activities even if no asbestos is present.

Due to the technical complexity of the NESHAP regulation, we urge you to call us for further information before performing renovation or demolition work at your facility.

Notification of Demolition and Renovation Form

There are now two forms for notification of demolition and renovation. The EPA form is the old form that has been used for notifications sent to the Illinois Environmental Protection Agency. The new form is a combined form that can be used for notifications sent to IEPA, Illinois Department of Public Health (IDPH), and Cook County. A separate copy must be sent to each agency. If you are required to send a form to IDPH or Cook County, please use the combined form. If you are only sending a form to the Illinois EPA, you may use the IEPA form. The Illinois EPA will accept either form. These forms are in PDF format. Download and save the form to your computer. You can fill out either form electronically but you must print it in order to provide the required original signature. Once completed, mail it to the above address.
