A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, DECLARING THE RESULTS OF THE CITY OF CISCO REGULAR ELECTION FOR MAYOR, COUNCILMEMBER PLACE I, & COUNCILMEMBER PLACE II OF MAY 3, 2025.



IT IS FURTHER FOUND AND DETERMINED that the results of the election as tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.


