All parties to this Agreement further agree that for the duration whereby the Clubhouse User received the key to the time it is returned to the Amenities Committee key contact, including the time stated in the Agreement, all liability for damage to the Clubhouse, to the common area surrounding the Clubhouse and to the personal or real property of the Association located in and around the Clubhouse shall be the responsibility of Clubhouse User. _____ (initial)

To secure performance under this User Agreement, Clubhouse User shall provide a security deposit check in the amount of \$200.00, (two hundred dollars) payable to **Valencia Hills Condominium Association, Inc.** This check shall be held without depositing it until noon of the day following the event date. At that time, if the Clubhouse and its premises have not been cleaned or if the Clubhouse key has not been returned or if there is damage, the security deposit check shall be deposited and not refunded to the Clubhouse User. _____ (initial)

The Clubhouse User agrees that any cost for cleaning, repair or replacement due to any loss or damage to the Clubhouse or Association property (real and/or personal) shall be withheld from the security deposit. Should such cost of cleaning, repair or replacement exceed the security deposit, Clubhouse User and/or Owner member shall promptly reimburse the Association for any excess cost. _____ (initial)

The Security Deposit will be refunded, providing the following items have been completed by noon following the event date.

Valencia Hills Clubhouse Rental/Use Agreement Checklist

- 1. Clubhouse User agrees to be present for the entire duration of the Clubhouse event.
- 2. No persons under the age of 21 are to be left unsupervised by an adult.
- 3. Clubhouse User agrees to limit event capacity (self, guest, helpers, vendors, etc.) to no more than fifty (50) persons within the Clubhouse.
- 4. Guests of the Clubhouse User's event are not permitted in the pool area or tennis court.
- 5. Dogs are not allowed in the pool/ pool area or tennis court.
- 6. The sitting area in front of the Clubhouse can be used for the Clubhouse User's event. Make sure this area is left clean and wastebaskets are emptied.
- 7. There is "No Smoking or Vaping" inside the Clubhouse. Smoking is permitted in the sitting area in front of the Clubhouse. Cigarette butts are to be placed in smoke receptacles.
- 8. No glass shall be used outside the Clubhouse.
- 9. Furniture, carpet, walls and floors must be cleaned and/or vacuumed and returned to the condition and position in which they were found.
- 10. Kitchen must be cleaned, clean microwave interior and exterior, refrigerator interior and exterior, mop the floor, empty the wastebasket and place a new bag liner inside the wastebasket. Trash bags are usually kept under the sink.

- 11. Range and oven must be cleaned and left off. Turn off kitchen and restroom faucets.
- 12. Bathroom must be cleaned, wastebaskets emptied, place a new bag liner inside the wastebasket, clean toilets, urinals and mop floors.
- 13. Air conditioning must be turned to 78 degrees in warm weather; heat must be left on 55 degrees in cold weather.
- 14. If you have paid an additional \$15.00 for use of the grill, the Pool Area near the grill must be cleaned. Please make sure the propane tank is turned off.
- 15. The Clubhouse grounds including the bridge and approach walks must be cleaned of trash, balloons, cans, bottles, decorations, etc.
- 16. All trash must be placed in tied plastic bags and left on Balearic Drive curb near the Clubhouse sign.
- 17. Check both restrooms to make sure all water is turned off and toilets/urinals are not running.
- 18. Turn off all lights in restrooms.
- 19. The TV should be shut off and the Roku remote must be placed back in the box.
- 20. Hallway door that leads to pool deck should be left **unlocked only** in the summer. It is locked during the winter. Leave the hallway light on.
- 21. A charge of \$10.00 per day will be assessed for failure to return the key by noon the next day after the event. An additional charge will be assessed to correct damage or for any violation of the Rules and Regulations of the Association.
- 22. No one is allowed to sleep over in the Clubhouse. Clubhouse User may not bring in sleeping bags, linens, pillows or other sleep/slumber item.
- 23. After the event, the Clubhouse User must (a) lock the front and back glass door, (b) lock the door to the Restroom Hallway from across the kitchen and (c) make sure no one is remaining in the Clubhouse.
