The purpose of Leadership Academy is to provide Directors & Administrators with leadership skills necessary to enhance the quality of child care in the state of Oklahoma. Participants complete 47 hours of formal training over a 6 month time period. Training topics included: Communication, team building, ethics, leadership traits/behaviors/characteristics, advocacy, mentoring, coping with change, discipline, best practices in early childhood administration and other leadership concerns.

Tis (& always is) The Season for Toy Safety

It's that time of the year again. With so many new toys on the market, it's easy for parents to forget toy safety in the rush to finish holiday shopping. The good news is that the U.S. Consumer Product Safety Commission (CPSC) and U.S. Customs and Border Protection (CBP) have already prevented many unsafe toys from hitting the shelves and toy recalls have dramatically declined overall. Unfortunately, many toys can still be dangerous when used improperly or by younger children.

A new report by the U.S. Consumer Product Safety Commission (CPSC) found that an estimated 185,500 children under the age of 15 were treated in emergency departments for toy-related injuries in 2015.

Children under the age of five accounted for nearly half of these injuries. Cuts, scrapes, and bruises were

the most common toy-related injuries, with most injuries affecting the head or face. Out of a total of 50 categories of toys, non-motorized scooters were involved in one out of every four injuries.

There are several things to keep in mind when shopping for toys for children:

Age-appropriateness

Not all "safe" toys are safe for all children—what's safe for your oldest child may still pose a danger to your youngest. Always follow the age recommendations and read the warnings on toys to check for safety hazards. Teach your older children to keep their toys away from their younger siblings.

Safety Gear


When buying bicycles, skateboards, scooters, skis/ snowboards, and similar toys, buy the proper safety gear as well. Make sure helmets are fitted properly. Most helmets should be replaced at least every five to ten years and after an impact.

Button Batteries and Magnets

The small, powerful magnets found in magnetic building sets and desk toys can be lethal when ingested. While some of these products have been recalled, similar items are still on the market. Button batteries (can cause internal chemical burns in less than two hours when ingested. These batteries can be found in some games, toys, musical cards, watches, and flashing shoes. Make sure to keep these away from young children.

Recalls

You can also subscribe to the CPSC Product Recall list to keep track of toys that have been pulled from the market because of safety issues.

OBI Live Scan Office & Mobile Unit Fingerprinting Instructions

The Office of Background Investigations pleased to announce that we are now providing fingerprinting services to DHS applicants!

OBI opened a Live Scan office in the Sequoyah Building, located in C-26, on July 1, 2016. Hours of operation are Monday – Friday from 8:00 am until 5:00pm.

The OBI Mobile Fingerprinting Unit will visit 15 county DHS offices each month, to assist DHS applicants obtain fingerprinting services. Please beware that these counties may change, as new vendor sites are opened in areas currently under served by Live Scan vendor sites. Hours of operation are Monday – Thursday from 9:00 am until 5:00 pm. Current Mobile Unit Schedule will be shared when it is available.

Criminal History Background Checks are a two part process:

- 1. Schedule an appointment for fingerprinting at www.identogo.com or 1-877-219-0197.
- 2. Submit a criminal history review request form electronically at https://bidspublic.okdhs.org. (*This link only works on Non-DHS network computers. To access this form from a DHS network computer use: https://lro.prod.okdhs.int/requestinternal.aspx)

Registry Update

The Center for Early Childhood Professional Development (CECPD) and the Oklahoma Professional Development

Registry (OPDR) have made a few changes to better serve child care programs and participants of the Registry.

CECPD has added a page to the website that is specifically designed to help child care program directors! It is the **Director's Chair** and is a resource for director's/organizations. It includes Frequently Asked Questions (FAQ's) that the Registry staff receive along with some "how to" videos. 4 Ways You Can Connect With Newly Appointed Officials

This month, elected officials around the country step into office. This is an important time to reach out to your newly elected officials and remind them of afterschool's role in your community, district or state. Offer to be a resource on the issue, and invite them to come see your program firsthand.

Not sure where to start? Here are some basic tips for reaching out to your representatives at all levels.

1. **Review statements**, platforms and media coverage to make sure you understand the winning candidate's position. Find a way to connect afterschool to their passion. Is their chief concern is creating jobs in your community? Tell them how afterschool offers workforce development opportunities.

Write the official to offer to be a resource on afterschool, and to set up a site visit to a local program. You can use our sample letter to get started. It is often helpful to provide information about the impact of afterschool in your community—and it's easy to do so with data points about afterschool in your state from the *America After 3PM* dashboard. Facts combined with relatable anecdotes can work together to create a strong narrative about the impact of afterschool. If you work with a program that receives 21st Century Community Learning Center funding, you should also be sure let them know about the impact it has.

Invite the official to visit an afterschool program. When Afterschool Ambassador Kim Templeman contacted Congressman Tom Cole to visit her program, she called and left emails with his office. A representative from his office visited her program, and then encouraged the Congressman to attend too! During his visit, Rep. Cole saw firsthand what afterschool looks like, and Kim was able to show him the direct impact of federal funds on her program. This type of personal interaction can help any official understand more of what you do and how you do it—whether they represent you on a federal, state or local level. Before the official leaves, make sure to give them materials to take back to their office so they can start making the case for afterschool. Check out our advocacy basics to learn more.

Stay in touch! After your visit, write the official to thank them for attending, and reiterate any points that you think are important for them to remember. You might also think about thanking them publicly, through social media or a blog about their visit. This is a good place to provide photos and stories, so those who aren't able to physically attend your program can see what it looks like as well. Don't forget to follow up, so that when you need support, you have a warm relationship to ask for it.

Want to make an impact while you're in the process of reaching out to officials? Contact Congress, sign the petition, or write your newspaper.
