




























12. DO YOU FEEL SAXON HARBOR HAD AN ADEQUATE NUMBER OF BOAT RAMPS (3)?






- "Please consider rerouting the creek. 2 years ago we had moderate rainfall, the creek overflowed and flooded into the harbor bringing in a considerable amount of debris. Also, Saxon Harbor has had a reputation of a party spot, notably the campground. I have spent many of nights in my boat being kept awake by rowdy campers in the campground, well past the quiet hour of 10:00PM. I understand people need a place to unwind and such, but for families and older couples, especially transient boaters, the harbor can be a turn off at times due to the rowdiness of the campers. If you tour any other marina with full amenities in Wisconsin, Michigan and Minnesota, you will find the patrons to act in a civilized manner. Why is Saxon Harbor so different? The easiest way to combat the partiers from taking over the harbor and the campground is unfortunately to raise the rates and make the prices unreachable for the lower income party crowds. Other than paying camping fees, the low income partiers aren't the ones spending money in Iron County and Saxon Harbor, the families and transient vacationers/boaters are.

- This lengthy comment was also posted on your Facebook page: I camped at Saxon 164. Harbor the night of June 18, 2015. I'd come to Iron County to photograph the historical markers in the area. Although I'd been warned when I made my reservation that a "large group" had made a reservation at the campground, I had no idea what that meant. When I arrived late that afternoon, one group was playing a radio so loud I went to complain to the "camp manager". She was so rude as she stood at the top of her trailer stairs looking down at me with her hand on her hip. She snarled at me, "No one has ever complained about the noise before". Later in the evening, the group placed HUGE speakers in the campground shelter (right next to where I was camping) and BLASTED their music. I once went to use the bathroom during this nightmare, and the walls were shaking from the boom of the bass. NOTHING was done to stop the noise. I looked around the campground, NO ONE was outside; everyone, including a family with young children that had pulled in after I'd arrived, had retreated inside their campers, ostensibly to avoid the noise. That's what I did. Went into my camper and turned up my own radio with classical music. I don't remember what time the noise stopped, only that it was late into the night and by then I was SO FURIOUS that I left the next morning without paying. As I went to the bathroom before leaving, one of the crowd's massive dogs that had been left chained up to a tree (while everyone went inside to sleep) barked and growled at me unabated. It was my first time to camp outside of one of Wisconsin's state parks. It was the MOST MISERABLE experience I've ever had at a Wisconsin campground. The next morning I shared my experience with members of the Iron County Historical Society (who I'd come to meet with). They acknowledged the problems with drinking and drunks and noise at this campground, and also that nothing had been done to stop it despite numerous complaints. It was unimaginable to me that such a gorgeous, gorgeous location could be controlled by a group of loud, obnoxious drunks. The State Parks would NEVER allow that kind of behavior. Why does Saxon Harbor? And what about that "manager"? What's the point of having a manager if she doesn't ensure the safety and enjoyment of all the guests? Saxon Harbor, one of the most beautiful places I've ever visited, was completely ruined by the allowed behavior of a group of drunks. PLEASE seriously consider strict rules of campground conduct for when Saxon Harbor reopens, so that everyone who visits is able to enjoy the pristine beauty of this amazing location.
