Please note that if your child is auditioning for a lead role, they must audition individually.

## Dear Parents & Guardians,

Thank you for bringing your child to audition for HCMT's fall production of *Shrek Jr*. As a parent myself, I realize you have many options for activities for your children and I appreciate you supporting your child in this endeavor, and placing your trust in us. The production team is dedicated to creating a fun and safe environment for the entire cast. Please take a few minutes to look over the very important information outlined below.

- Our insurance policy requires all cast members become members of HCMT. Your tuition includes the membership fee and must be paid in order to participate.
- All cast members under the age of 10 must be accompanied into the building and the auditorium for rehearsals and performances. They must also be signed in and out by the parent or guardian at the start and end of the rehearsal (they will not be able to leave the building unaccompanied).
- Cast members may be asked to provide some basic costume pieces.
- Parents or guardians will be asked to volunteer during tech week and productions. There are many ways to get involved. More information will be provided once we begin rehearsing this fall.
- Rehearsals will be every Tuesday and Thursday from 4-6pm September 16<sup>th</sup>-November 25<sup>th</sup>. No rehearsal on Tuesday, November 11<sup>th</sup> or Thursday, November 27<sup>th</sup>.
- While we have a fixed rehearsal schedule, please note that during tech week we will most likely have rehearsals Monday-Thursday and they will not necessarily end at 6:00pm. Rehearsals this week could go as late as 8-9 pm. We will give you all plenty of advanced notice, but we want to make sure you mark off **tech week December 2<sup>nd</sup>-6<sup>th</sup>** on your calendars. There may also be times when leads or featured dancers will be asked to stay until 7 on regular rehearsal days. Again, you will have notice of this. We will also have a Super Sunday rehearsal on Sunday, November 16<sup>th</sup> 10am-4pm.
- Because we have a limited amount of rehearsal time, we do hope that the cast members practice outside of rehearsals each week in order to be prepared and put the best production forward.
- Performances will be Friday, December 5<sup>th</sup> and Saturday, December 6<sup>th</sup> @ 6:30 pm and Sunday, December 7<sup>th</sup> @ 2:30 pm
- Each parent/guardian will be given the opportunity to purchase a ticket that will admit them to all three performances for \$40. These tickets will bear the name of the adult and cast member and a photo ID will be required at each performance for entry. There is a limit of 2 parent/guardian tickets per family. Our ticket chairperson will have further details upon request.
