# 4. FIRST AID MEASURES

**Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. # ACCIDENTAL RELEASE MEASURES

**Personal Precautions, Protective Equipment and Emergency Procedures:** Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. 
