He reported that TTO staff and their families remain healthy and vigilant during the pandemic and commended the staff for completing member district tax reporting (W2, 1099 & ACA) earlier than in any previous year. Additionally, Treasurer Getty stated that one of his FY21 goals is to consolidate accounts payable & payroll bank accounts into a single account for each district by the end of the fiscal year. This consolidation will increase efficiencies and reduce total annual bank service fees.

Review School Districts Official Records

Board of School Trustees discussion and review of the Lyons Township Schools and Coop's financial records for December 2020. Treasurer Getty pointed out that the total member district fund balances are approximately \$20,000,000 higher at 12/31/20 than they were at 12/31/19.

NEW BUSINESS:

Quarterly Investment Report – December 31, 2020

Treasurer Getty reported that the Lyons Township Treasurer Office's total investment portfolio continues to outperform its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury &

Agency Index) with 21.06% higher returns (LTTO: 3.106% vs. BOA ML 1-10 Index: 2.566%) in the second quarter of FY2021. He also reminded the Trustees that each of the detailed quarterly investment reports are available on the TTO's website and that the office continues to develop relationships with local banks and negotiate above market rates on the short-term portfolio funds. These relationships have resulted in strong returns for our member districts that have supported the overall portfolio returns in a declining interest rate environment.

OLD BUSINESS:

Matters related to the possible withdrawal of Lyons Township High School District 204 from the Township Trustees of Schools, Township 38 North, Range 12 East, County of Cook, State of Illinois at the conclusion of FY2021:

The LTTO Trustees asked the Treasurer Getty to undertake an examination of the LTTO's books and records determine if there are any corrections that may be required to address the allocation or misallocation of interest earnings to all member districts. Treasurer Getty presented a summary of his analysis of all the member district fund balances and interest distributions from 1995 – 2012. This analysis concluded that there appears to be both over and under allocations across the member districts.

Motion by President Thiessen: In anticipation of the withdrawal of D204 from the TTO at the conclusion of litigation, the Board requests that the Treasurer undertake an examination of the LTTO's books and records through June 30, 2020 – the most current audited financial statements - to determine if there are any additional corrections that may be required to address the allocation or misallocation of interest earnings and/or expenditures; and to further determine if/how these corrections would affect not only D204 but any/all of the LTTO Member Districts and to present his finding to the Trustees at the February Board meeting.
