DRAFT MINUTES

Call to Order – Possehl called meeting to order at 11:47 AM

Roll Call – Possehl and Balsiger present, along with Salmon, DPW/Admin, Lindert, Clerk/Treasurer, and Craig Trewartha. Holtan absent. Joel Burkhardt joined at 11:57 AM

Verification of the Posting of Agenda – Lindert stated posted in 3 public places along with website.

Agenda Approval – Balsiger/Possehl. Motion carries.

Minutes Approval – Balsiger/Possehl. Motion carries.

Comments from the Floor - Trewartha just stated question on proposed snowmobile route and wondering changes being made. Moving to agenda item below.

NEW BUSINESS

Snowmobile Route

Consider E. LaFollette St. (south side). Salmon brought up email from Joel Burkhardt and explained route concerns that was previously approved.

- Group is concerned on having to rely on the lake to be frozen for their use in to the Village
- Discussion on E. LaFollette St. route and stated pros and concerns
 - o Discussion on using 2nd Alley, onto 2nd Street into gravel parking lot at Kwik Trip
 - Salmon mapped out new route on screen
 - Salmon explained new route to Burkhardt once he joined
- Discussion on lot lines and Possehl stated finding a better route next year, possibly behind sewer plant. Discussion on winter projects and having to contact Kwik Trip for approval
- Motion to recommend the new route, using 2nd Alley and E. LaFollette St., to Village Board Possehl/Balsiger. Motion carries.

Update Language in the Zoning Ordinance

- Salmon explained topic and reason why it is an agenda item. Salmon pulled up email from Village attorney, Paul Johnson and ordinances now in place
- Discussion on past vs. future and what Village can do going forward with modified ordinances
- Discussion on parking on gravel and parking vehicles
- Balsiger stated he is fine with modifications as long as Village attorney thinks this will stand
 up in court. Have been to court with this individual before in past. Salmon stated the
 Village needs to clean up multiple zoning ordinances per Village attorney and continue to
 issue citations
- Salmon and Lindert will do work to modify ordinances what is needed for Village Board meeting on November 1
- Motion to recommend changes to Village Board for Nov 1 Possehl/Balsiger. Further discussion on recommendation being clear enough for Village Board. Question regarding if Village attorney's guidance is enough and how to modify to have "legs to stand on."

Sec. 6-61. - Nuisance, dangerous, or vicious dogs.

(a) Classification. The Columbia County Sheriff's Office or any other law enforcement officer may bring cases to classify dogs within the county as a nuisance, dangerous, or vicious to the village public protection committee. the sheriff's office is responsible for presenting substantial evidence to the village public protection committee for the requested classification of a specific dog to the village public protection committee. the sheriff's office may consult with an outside agency when gathering evidence, the owner(s) of the dog and the victim(s) shall be informed of the village public protection committee meeting date and time and shall be provided with the opportunity to participate in the meeting.

A majority vote is required by the village public protection committee to approve or deny the requested classification. The village board has superseding authority over the village public protection committee with respect to the decisions to classify a specific dog as dangerous or vicious. The village board may overturn the village public safety committee decision by a majority vote.

(b) *Nuisance dogs.* the owner of any dog that has been classified as a nuisance shall keep said dog securely enclosed on the owner's premises and shall keep it muzzled when exercising it. where there is evidence such animal intimidates persons from the use of some or all of their public property, the sheriff or his deputies may order the animal muzzled, leashed, or restrained.

Any person violating this section shall be subject to the penalty listed in section 6-2.

(c) *Dangerous dogs.* a dog that has been classified as dangerous may, but is not required, to be euthanized after the first incident. any dog that has previously been classified as dangerous and has a second incident in which it would subsequently be classified as dangerous shall be euthanized.

Any person violating this section shall be subject to the penalty listed in section 6-2.

(d) Vicious dogs. any dog that has been classified as vicious shall be euthanized.

Any person violating this section shall be subject to the penalty listed in section 6-2.

Editor's note— Ord. No. 2022-21, § 2, adopted Oct. 4, 2022, repealed the former § 6-61 and enacted a new § 6-61 as set out herein. The former § 6-61 pertained to vicious dogs and derived from Code 1986, § 7-1-6(b) (1).
