SHOW RULES

1. ELIGIBILITY: All Colorado Artists.
2. SHOW DATES: February 24, 2019 - March 29, 2019
3. MEDIA: Any 2-D fine art media, including photography. All work must be original by the artist (*No prints from original work*).
4. THEME: Open theme abstract
5. ENTRIES: Each artist may enter up to three (3) works. You must pre-register. Registration in on a first come basis. **NO SUBSTITUTION OF ARTWORK AFTER REGISTRATION IS SUBMITTED**
6. FEE: \$15 each, or up to 3 works for \$35.00 (\$10.00 each, or up to 3 for \$25.00 for LAC Members). Checks payable to Lakewood Arts.
7. SPECIFICATIONS: When applicable, works must be framed or have wrapped, painted edges with staples visible only from the back. Wall-hung work must be ready for hanging with screw eyes and wire. The wire on the back cannot be seen when the artwork is hung. *Works must be identified on the back with the artist's name, phone, and title of work. Have work ready prior to delivery. The titles and price of the artwork cannot be changed.*
8. SALES: Works need not be for sale. A commission of 20% will be charged for all sales.
9. JURYING: Works will be juried for acceptance into the show.
10. AWARDS: (Winners will be notified)
 - 1st Place: \$100
 - 2nd Place: \$75
 - Merit Award: \$25 each
11. INSURANCE: No insurance is provided
12. All work sold will be released to buyer at time of purchase.
13. A \$15 per day storage fee will be charged for work not picked up by time stated in 'Deadline and Events'. LAC IS NOT RESPONSIBLE FOR WORK NOT PICKED UP ON TIME
