## RECOMMENDED STEPS FOR PREPARING YOUR SCHOOL'S SELF-STUDY

- 1. Attend COE's Workshops.
- 2. Assign Self-Study committee members.
- 3. Download COE's Check Sheets and review the Self-Study Manual.
- 4. Share COE workshop information with the Self-Study committee members.
- 5. Issue the school's Policies and Procedures Manual aligned with COE's standards.
- 6. Provide training to all personnel on newly adopted Policies and Procedures.
- 7. Committee members start working on the writing of the Self-Study sections and Exhibits.
- 8. Conduct weekly Self-Study committee meetings to confirm progress.
- 9. Ask committee members to provide feedback on Self-Study sections assigned to other personnel.
- 10. All personnel must be involved with the Self-Study and Exhibits: creation, data collection, and review.
- 11. Consult often with COE staff for clarifications and guidance.
- 12. Have draft Self-Study ready three (3) months before the scheduled accreditation visit.
- 13. Issue final Self-Study two (2) months before the scheduled accreditation visit.
- 14. Team Leader reviews the Self-Study and provides feedback during Preliminary Visit.
- 15. Make corrections to Self-Study as per the Team Leader's recommendations.
- 16. Submit the revised Self-Study to the Team Leader and COE Office as per provided deadline and instructions.
