### September 2 Program: Tree Care

Crestwood's trees are one of its distinguishing features and one reason Crestwood is such a great place to live. It's the end of August and many Crestwood trees are showing signs of stress. Drought, oak wilt, and new construction over old tree roots have been tough on our trees.

*The business meeting will begin at 6:30 PM.  
The program will begin shortly after 7:15 PM.*

To help us all learn how to protect our trees, we're hosting a special program on tree care after the September 2 board meeting. Our presenters will be expert arborists from Preservation Tree. Micah Pace is an International Society of Arborists (ISA) Certified Arborist specializing in Urban Forestry. Billy Cook is an ISA-certified arborist, Texas Oak Wilt Certified, and Preservation Tree's Fort Worth Branch Manager. Some distressed trees can be rescued; others cannot. Our speakers will address protection of healthy trees, steps to rescue distressed trees, and how to deal with trees that cannot be saved.

We all live with watering restrictions and some of us have had direct experience with oak wilt. No matter how much you know about tree care, we hope you'll attend this program and come prepared with questions. The business meeting begins at 6:30 PM. The program will not begin before 7:15 PM. Both will be held at the Central Christian Church, 3205 Hamilton Avenue. ***Refreshments will be provided!!!***
