The Heathrow Pool will open on May 24, 2025, at 11am for the season. Hours of operation will remain the same as in prior years. Please check the subdivision website for updates.

2025 Assessments/ Pool Repairs

South Oaks Subdivision and Heathrow Bath Club The assessments and budgets have been set for 2025 for both the South Oaks Subdivision and the Heathrow Bath Club.

> The South Oaks Subdivision assessment remains the same as last year at \$230 and is due on January 31st, 2025.

The Heathrow Bath Club assessment is set at \$800 and will be due on February 28, 2025.

We have two projects at the pool that require immediate attention. The coping stones surrounding the edge of the pool had deteriorated and need replacement.

The project to replace the coping around the entire pool cost is \$20,580.85. This also includes replacing the caulking around the pool. Pro Pool started the process to remove the old coping material at the end of last season and plans to have the replacement done before the beginning of the 2025 swim season.

(Broken coping is considered a safety hazard by St. Louis County)

The second immediate repair involves a leak in one of the lines to the pool that was detected at closing for the 2024 season. The repair requires removing and replacing concrete and will cost approx. \$4200.

Homeowner Maintenance and Upkeep

The Trustees continue to receive complaints about the upkeep of properties.

Several complaints have been received about homes with peeling, chipped, and faded paint, warped shutters, missing siding, landscape walls falling, mold on siding and fences, overgrown landscape beds, and other general maintenance issues.

St. Louis County Code Enforcement will cite homeowners for issues listed above, including peeling paint and mold (algae) on siding.

Home Improvements

Please remember that South Oaks Indentures <u>REQUIRE</u> that the Trustees approve all requests for exterior improvements <u>BEFORE</u> they are made to homes.

Pre-approval is required for decks, pools hot tubs, fencing, concrete work, landscaping, painting, and any type of structural modification. An Improvement Request form is available on the subdivision website or from any Trustee. When in doubt, ask a Trustee.
