FMCIS Trail Ribbon Cutting Ceremony

This event was a long time in coming - the Central Michigan Railroad ceased operations twenty two years ago! And we were blessed with a picture perfect sunny April morning for the festivities.

The Friends' Group, along with local communities, MDNR and MDOT held a ribbon cutting ceremony at the St. Johns Rotary Park pavilion on Saturday, April 18, 2015. Bicyclists from Ionia and Owosso, and other towns along the trail, started out early in the morning, meeting at the pavilion in St. Johns. The program was emceed by our chairperson, Avery Weaver, and included presentations from Dana Beaman, Mayor of St. Johns, Nancy Krupiarz, Executive Director of the Michigan Trails and Greenways Alliance, Kristen Bennett from the MDNR, and Michael Smith from MDOT.



Festivities were culminated with a ceremonial ribbon cutting followed by light refreshments. All in all, a perfect celebration for our newly completed trail.

FMCIS and FMGRVT Receives Award

The Fred Meijer CIS Trail along with the Fred Meijer Grand River Valley Trail were the gracious recipients of a "Putting Ionia on the Map" award given by the Ionia Area Chamber of Commerce at their 2016 Annual Community Awards held on Saturday, January 30, 2016. Kathy Simon and Janice Gustafson were in attendance to accept the award for the CIS Trail and George Raimer accepted on behalf of the Grand River Valley Trail. Ingham County Taking Regional Trails to the Next Level

Friends of the Fred Meijer Clinton-Ionia-Shiawassee Trail should know that their neighbors to the south (Ingham County) are undergoing a regional trails and parks planning process! Voters approved a millage in November, 2014, which will yield \$20 million over the course of the next six years for trails and parks acquisition, development, and maintenance. A task force of county commissioners is working with Mannik & Smith Group, a professional engineering firm, and Michigan Trails and Greenways Alliance to set up the plan and process for spending this funding. It is now up to the task force to review the report, recommend revisions and make final recommendations to the full board of commissioners by the end of February, 2016. Once the plan is finalized, it will be added as an addendum to the county parks and recreation master plan, which has also just begun its 5 year update process. Perhaps a trail connection from Lansing towards Clinton County and the Fred Meijer CIS Trail

will be a little closer in our sights due to this new millage!

Progress on Michigan's Trail Grid

Two of Michigan's cross-state trail arteries, the Iron Belle Trail (Belle Isle to Ironwood) and the Great Lake to Lake Trail (Port Huron to South Haven) received a flurry of activity these past couple months. Notification of small grant opportunities totaling \$350,000 with up to \$30,000 each for development of segments of the Iron Belle Trail was posted by the Michigan Department of Natural Resources. Communities and trail groups across the more than 1,270 mile hiking route as well as the more than 790 mile biking route scrambled to get their applications together for planning and engineering, signage, and trail construction. And since the Iron Belle Trail hiking route uses the Great Lake to Lake Trail from Stockbridge to Galesburg, any funding for trails along that route will impact progress on that trail as well! Grant decisions are expected within the next 6 to 8 weeks. In the meantime, MTGA will continue to assist communities from Detroit to Bay City with the myriad of details in setting up their trail segments.

News from the Michigan Department of Natural Resources

2015 was a stellar year for trails. It is hard to believe a year ago we were celebrating the opening of the FMCIS trail and now it feels like it has always been there. The DNR and MDOT have received many happy comments from trail users as we are out and about on the trail now and again. This past year on the trail for the DNR has been a flurry of paperwork and preparations to continue to add much needed amenities to the trail. 2016 should see some coming attractions in several communities.

In June the trail and the DNR's portion of the Fred Meijer River Valley Rail Trail Network was leased to the Midwest Michigan Trail Authority. We are proud to have them as part of the DNR family. They will do a wonderful job of managing and maintaining the existing trails and helping the DNR to build the remaining portions of trail.



In September a group of DNR and MDOT professionals went out on the trail to enjoy a morning bike ride and then spent the afternoon discussing trail business. We covered general trail joint topics such as maintenance, contracting issues, signage and acquisitions. The ride was a bit rainy, but fun was had by all. The trail held up fantastic through the rain and really showcased all the hard work that was done by the DNR and MDOT as well as all of the fantastic communities and volunteers.
