TITLE: APPROVAL OF CONTRACT WITH INNOVATIVE HYDROLOGY FOR HYDROLOGY AND CLIMATOLOGY SERVICES (NFWF 79950/SLPT FUND 1341)

- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and
- WHEREAS, the Summit Lake Painte Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and
- WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and
- WHEREAS, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe; and
- WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, plants, and infrastructure within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and
- WHEREAS, the Summit Lake Paiute Tribe has a network of hydrological and climatological monitoring equipment and telemetry systems; and
- WHEREAS, this network needs periodic maintenance that is outside the expertise of regular employees of the NRD and that installation of new pieces of equipment in this network may be desired in the future; and
- WHEREAS, the NRD and Innovative Hydrology have previously worked together on these projects; and
- WHEREAS, in addition, Innovative Hydrology will provide consulting services to NRD for the SOARR observation network project (SLPT Fund 1341 NFWF 79950); and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering into the Agreement with Innovative Hydrology for the above stated purposes; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
