CONSENT AGENDA

Motion Trustee Howard, seconded Trustee Bendix and carried unanimously to approve the July vouchers and invoices Trustee Burgess reviewed for reasonableness and which were submitted for payment approval. Payments totaling \$575,985.48 were authorized for all funds.

Clerk-Treasurer Valerie Quade had no update.

MAYOR

The Village Board recognized the boys track team on their season.

Motion Trustee Blodgett, seconded Trustee Bendix and carried unanimously to approve to raise the rate for accepting septic at the Waste Water Treatment Plant from \$0.06 per gallon to \$0.09 per gallon starting September 1, 2022.

Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to approve McKinley Miller the use of Village property to film her light horror film movie. Dates and places of the filming will be coordinated with the Police Department.

OFFICER IN CHARGE JAMES THOMSON

Officer in Charge James Thomson gave the following update:

SUPERINTEN-DENT DPW BOB HUTTEMAN

Motion Trustee Blodgett, seconded Trustee Bendix and carried unanimously to approve the following resolution:

WHEREAS, the Village Board of Newark, New York is considering the financing and construction of improvements for the Village of Newark Allerton Hill Reservoir Replacement, including the construction of a new 4 million gallon concrete water storage tank, control building, water main piping, electrical improvements, and appurtenances. The improvements also includes the demolition and removal of the existing reservoir

2022 July 18 Minutes of Village Board Meeting Page 2 of 5 structure and the restoration of all disturbed areas, together with improvements incidental thereto (the "project"); and WHEREAS, to aid the Board in determining whether such Project and financing and other actions of the Board in connection therewith (the "action") might have a significant effect on the environment, the Board caused to be prepared an environmental assessment form or similar information ("EAF"), a copy of which it attached hereto; and

WHEREAS, the Board duly reviewed the EAF and related documents with respect to the above-referenced project and duly considered the impacts which may be expected to result from the proposed action with the criteria set forth in the State Environmental Quality Review Act and the applicable regulations promulgated thereunder ("SEQRA"); and WHEREAS, the Board determined that the project was an "Type LAction" pursuant to SEORA; and

"Type I Action" pursuant to SEQRA; and WHEREAS, the Board determined that the project involved one or more involved agencies, mandating a coordinated review;

WHEREAS, the Board duly notified the other involved agencies pursuant to 6 NYCRR 617.6(3)(i) and indicated its willingness to be designated Lead Agency status; and WHEREAS, all of the involved agencies have consented to the Board's request to be designated Lead Agency status;

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF NEWARK DECLARES TO BE LEAD AGENCY FOR THE PROJECT FOR THE PROPOSED ACTION AND THEREFORE RESPONSIBLE FOR DETERMINING WHETHER AN ENVIRONMENTAL IMPACT STATEMENT IS REQUIRED IN CONNECTION THEREWITH AND OTHERWISE COMPLYING WITH THE PROCEDURAL AND SUBSTANTIVE REQUIREMENTS OF SEQRA; NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE BOARD OF NEWARK, NEW YORK AS FOLLOWS:

1. Based upon the review by the Board of the EAF and other necessary criteria, the Board hereby finds and determines that the proposed action is an "Type I Action" under SEQRA and will result in no significant impacts and therefore, such action is not one which "may include the potential for at least one significant adverse environmental impact," (b) "there will be no significant adverse environmental impacts," and (c) no "environmental impact statement" need be prepared, as such quoted terms are defined in SEQRA. Reasons supporting this determination are attached hereto and hereby made a part of this resolution for the purposes of SEQRA. This determination constitutes

and

a negative declaration for purposes of SEQRA and it has been prepared in accordance with Article 8 of the Environmental Conservation Law.

2. A copy of this resolution shall be placed on file in the office of the Village Clerk, where the same shall be available for public inspection during business hours and such notice of negative declaration shall be filed in such offices, posted in such places and published in such manner as shall be necessary to conform to the requirements of SEQRA.

Motion Trustee Howard, seconded Trustee Bendix and carried unanimously to approve supporting the negative declaration for Allerton Hill Reservoir Replacement.

Superintendent Hutteman gave the following update:

TIME FOR THE PUBLIC

Casey Carpenter of Grace Ave expressed her concerns regarding the speed of vehicles on Grace Ave and Wood Lane with kids walking, school busses and DPW. She inquired about sidewalks on Wood Lane for walking traffic. Mayor Taylor responded that the Village received a grant for the sidewalk that was in.

Paul Murphy of East Miller Street expressed the following concerns:

- Cemetery has been looking better however he had a burial by the barn on June 19th and he was embarrassed how it looked.
- He requested that if anyone hits/bumps/moves a cemetery stone that it needs to be fixed or reported.
- He enjoys that the fire alarm has not been going off and request that it stays that way. He doesn't believe it is effecting the amount of firemen showing up.
- He has noticed that the grates around the trees have not been weeded.
- He has noticed that not all the concrete flower pots have been used and is wondering where they are at as most were donated by residents.
- Requested that bushes or flowers be planted at bump outs as they are hard to see and people are losing tires.

CHIEF CHUCK WITT

Chief Witt discussed the following:

- He agreed that the fire alarm is not for the firemen. He has gotten about the same amount of calls from residents that like that it is not going off as he has for people that would like it to be turned back on.
