Proxy Bid Terms and Conditions

Bid By Proxy

Bid by Proxy will take place with the participant, at least 18 years old, completely filling out the "Bid By Proxy" form. Incomplete and/or illegible forms will be considered null and void. A representative will bid for the item on your behalf and will only bid in your place until other bidders stop.

Example: Your maximum bid is \$500 for an item that opens in the auction at \$100 and increases by \$25 increments. If other bidders bid up to \$300, your proxy will bid will be \$325. If all other bidders stop bidding, you will win the item for \$325.

Bidding Disclosure

Suggested retail values are only a guide. Participants at the event will determine the real value of each item through the bidding. All sales are final and there will be no exchanges, refunds, or substitutions.

Tax Deductibility

According to the IRS rules and regulations, the only tax deduction for the purchase of auction items from non-profit organizations is the amount paid in excess of fair market value. Bidding
