Pay for your purchase. We accept credit cards, business check, school check, cashier's check, or a money order. A W-9 or vendor application is provided if required. Payment will need to be received by S'Kool Smartz before an order will be shipped. Public schools, with approval of S'Kool Smartz, may submit a purchase order. If requested, notify us when requesting your brochures.

Shipping is free. Your order will be shipped by FedEx 3 weeks following receipt of your order forms. Allow an additional 3-5 business days for your shipment to be delivered. Large orders may be delivered by Carrier with a scheduled delivery

A confirmation will be emailed to you once we receive payment. Once received, your order will be submitted to our shipping department. You'll receive reports including a summary of sales and items sold by each student and class.
