

VILLAGE OF AMELIA, OHIO
Ordinance No. O-2015-47

**AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, CLERMONT
COUNTY, OHIO AFFIRMING THE FINAL APPOINTMENT OF
JEFFREY M. WOOD AS THE POLICE CHIEF**

WHEREAS, on April 14, 2015, the Amelia Village Council enacted Ordinance O-2015-26 appointing Jeffrey M. Wood to the position of Village Police Chief (Village Marshal); and

WHEREAS, Council for Amelia Village acknowledges the successful completion of the probationary period required by Ohio Revised Code Section 737.17 by Chief Jeffrey M. Wood, the transmittal by the Mayor of a record of Chief Wood's service during the probationary period, the Mayor's recommendation to affirm the appointment of Chief Jeffrey M. Wood as Chief of Police for Amelia Village, and

WHEREAS, Council for Amelia Village desires to concur with the recommendation of the Mayor;

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio that:

SECTION I. Council hereby concurs with the recommendation by the Mayor to affirm the appointment of Jeffrey M. Wood as Police Chief (Village Marshal) for Amelia Village.

SECTION II. All prior ordinances or resolutions or any part thereof, which are inconsistent with this ordinance or resolution are hereby repealed as to the inconsistent part(s) thereof and the remainder of said ordinances or resolutions not inconsistent with this resolution shall remain in full force and effect.

SECTION III. Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION IV. This Ordinance shall take effect and be in force at the earliest opportunity allowed by law.

MRS. Gerber moved to suspend the rules requiring three readings on three separate dates.
